**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**KNOW ALL MEN BY THESE PRESENTS,**

That for and in consideration of **FOUR HUNDRED TWENTY FIVE THOUSAND AND NO/100 (\$425,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **WILBUR BICE, IV and MONIQUE BICE**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **ROBERT A. JOHNSON and KATHERINE JOHNSON**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 8, according to the Survey of Oakridge, 2nd Sector, as recorded in Map Book 10, Page 50 A and B, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2024 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 10, Page 50.
7. 35-foot building line on front of lot as shown on recorded map.
8. 7 1/2-foot easement on rear side of lot as shown on recorded map.


