**GENERAL WARRANTY DEED**  
**With Right of Survivorship**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of ONE HUNDRED SEVENTY EIGHT THOUSAND AND 00/100 (\$178,000.00), and other good and valuable consideration in hand paid to Kess Cottingham and Jennifer Cottingham, husband and wife (hereinafter referred to as "Grantor(s)"), the receipt and sufficiency of which is hereby acknowledged, by the Hector Leon Sandoval and Amy Beth Leon (hereinafter referred to as "Grantee(s)"), Grantor(s) hereby GRANT(S), BARGAIN(S), SELL(S) and CONVEY(S) unto Grantee(s), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:




