CORPORATION WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of SIX HUNDRED EIGHTY THREE THOUSAND EIGHT HUNDRED ONE AND 00/100 DOLLARS (\$683,801.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Clayton Properties Group, Inc., a TN corporation (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Phillip Bradford (herein referred to as GRANTEE, whether one or more) the following described real estate situated in SHELBY COUNTY, Alabama to-wit:

Lot 108, according to the Survey of the Final Plat of the Subdivisions of The Foothills at Blackridge Phase 1, as recorded in Map Book 56, Page 66, in the Office of the Judge of Probate of Shelby County, Alabama.


Note: \$0.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

TO HAVE AND TO HOLD, to the said GRANTEE, his heirs and assigns forever.

And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEE, his heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEE, his heirs, executors and assigns forever, against the lawful claims of all persons.




