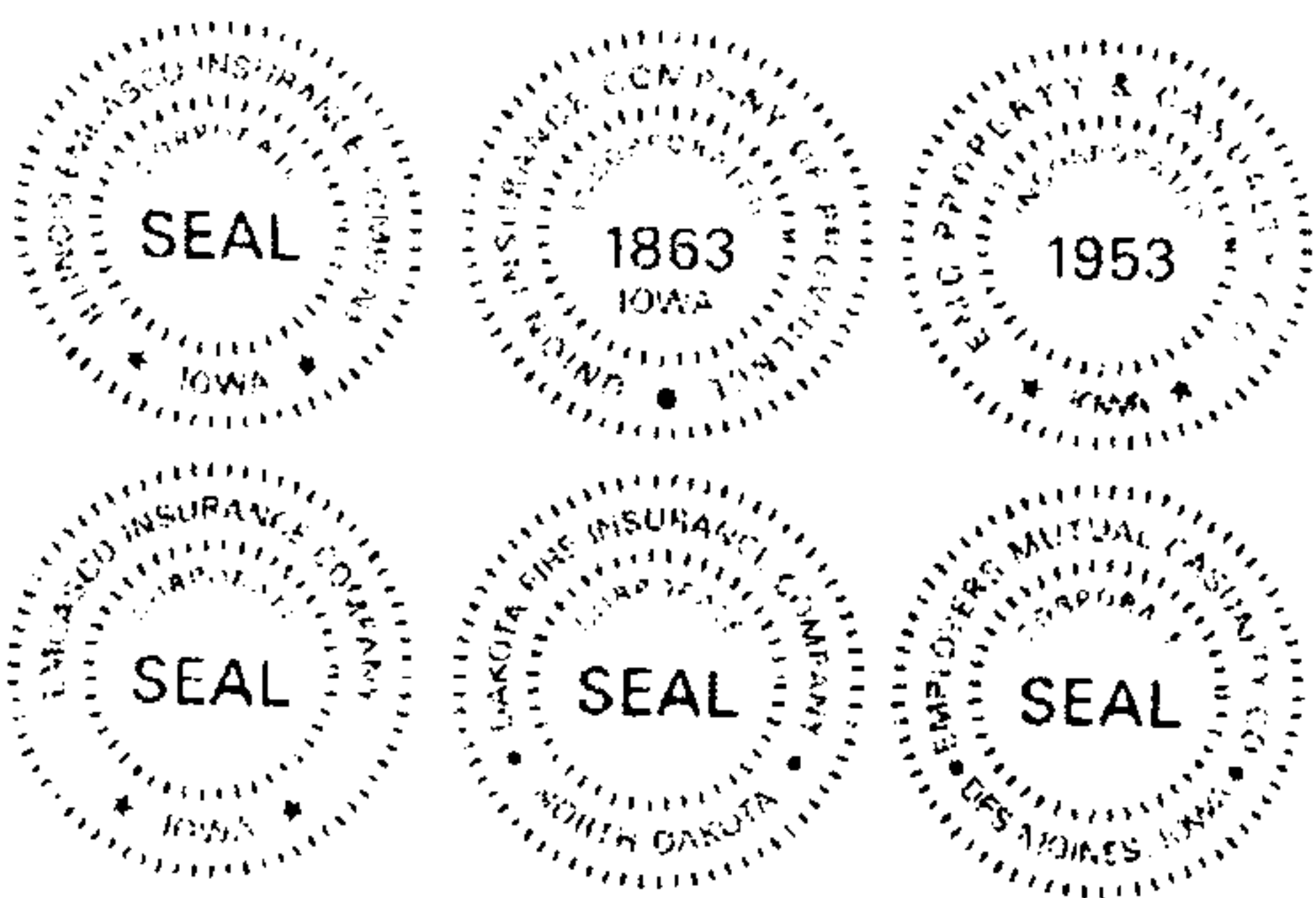
## AUTHORITY FOR POWER OF ATTORNEY
