 encumbrances of record.

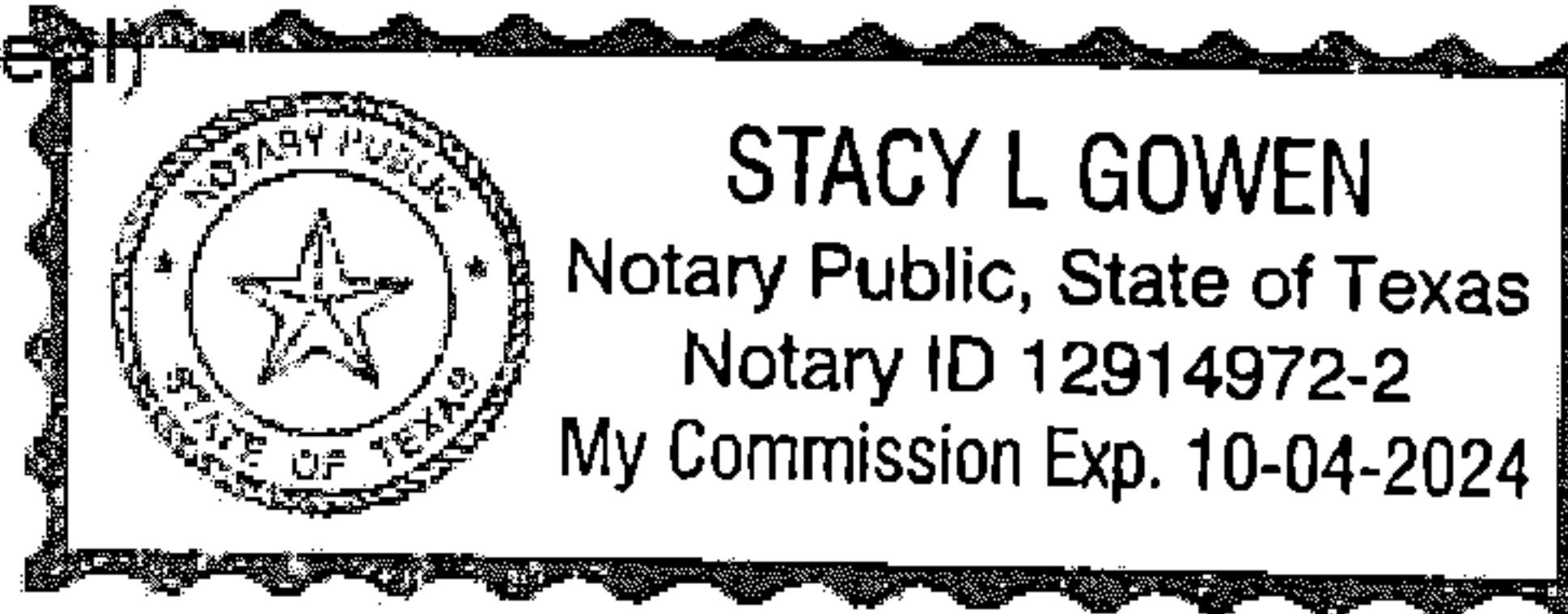
