ARTICLE IV – OFFICERS: Section 12. Power of Attorney.

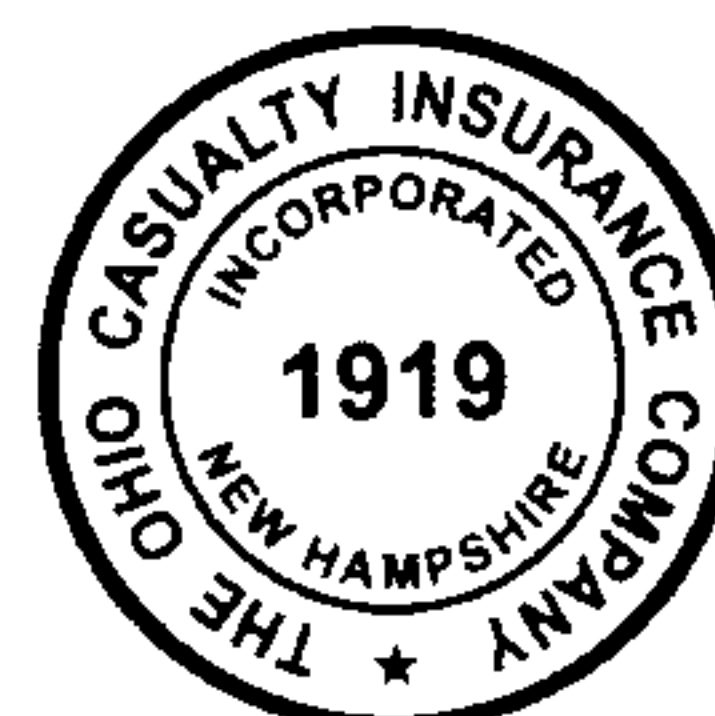
