That in consideration of Three Hundred Forty-Nine Thousand Nine Hundred and 00/100 (\$349,900.00) Dollars and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Vladimir Dimitrijevic (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

Lot 13, Chelsea Acres Sector 1, a map or plat of which is recorded in Map Book 57, Page 15, in the Office of the Judge of Probate for Shelby County, Alabama.

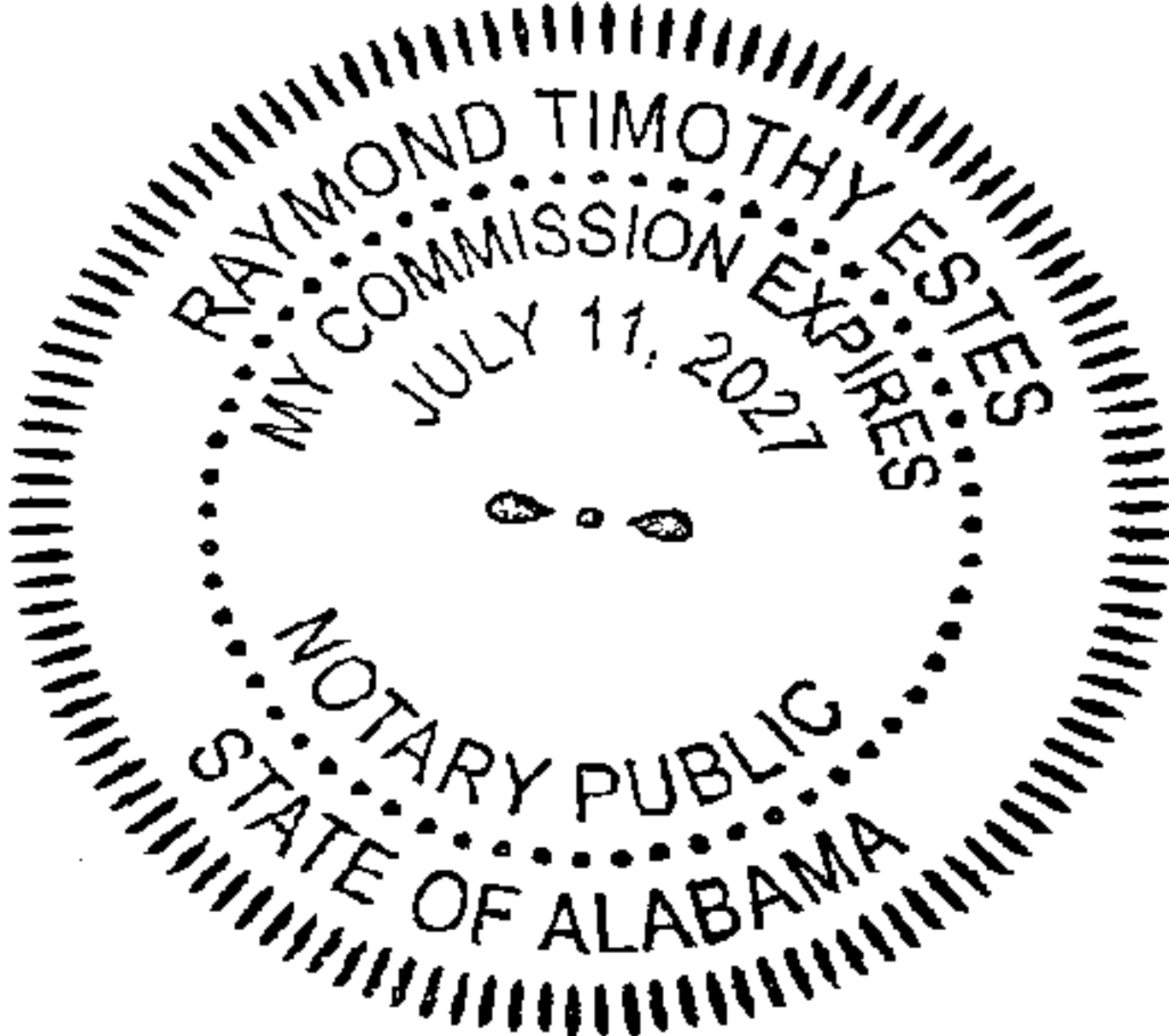


