That in consideration of **Two Hundred Eighty-Nine Thousand Four Hundred and 00/100 (\$289,400.00) Dollars** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Sandra Renea Johnson (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **Shelby** County, Alabama, to-wit:

Lot 29, according to the Final Plat of Koslin Farms Phase 2B, Sector 1, according to the map or plat thereof, recorded in Plat Book 58, Page 63, in the Office of the Judge of Probate, Shelby County, Alabama.

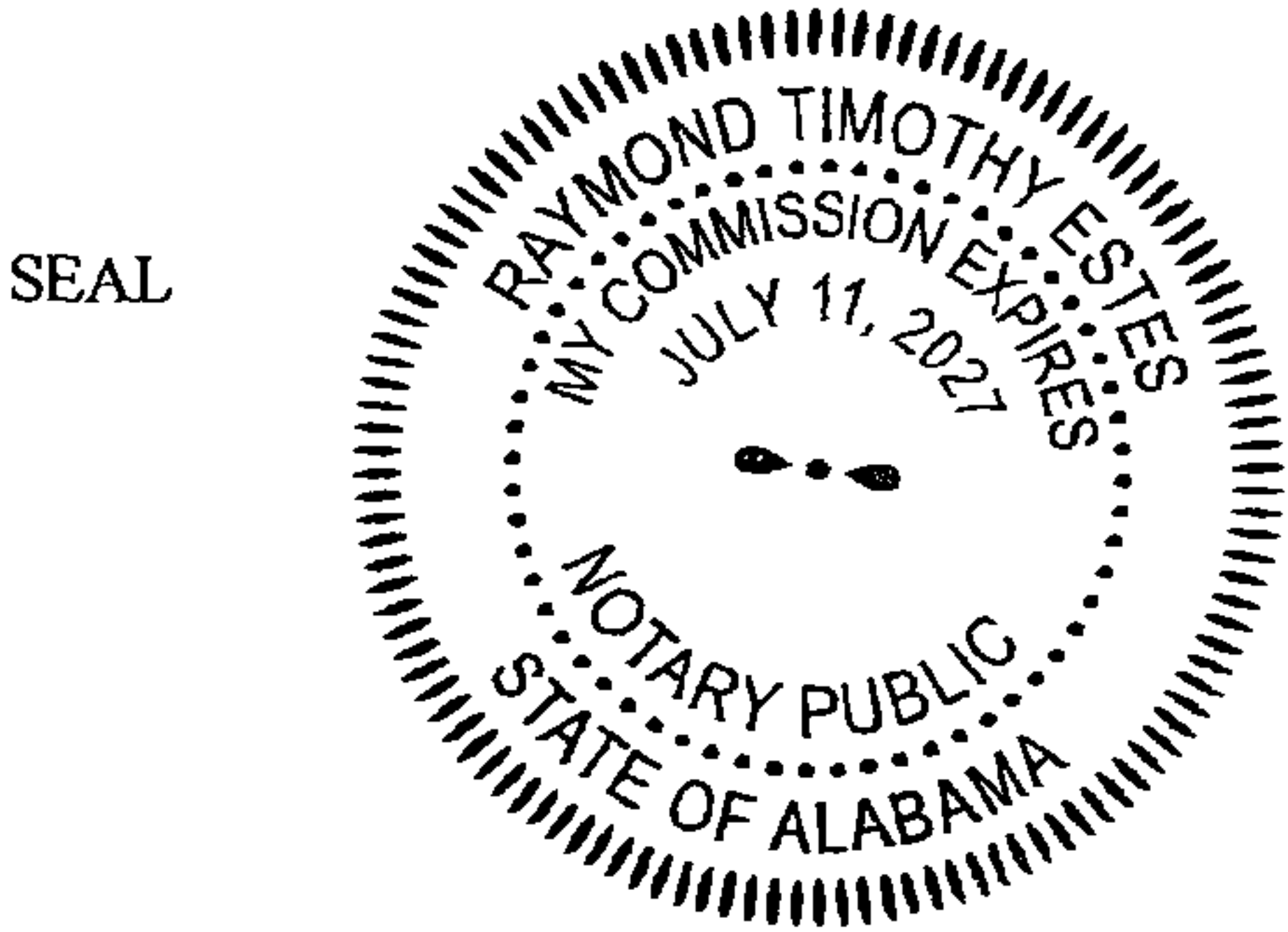

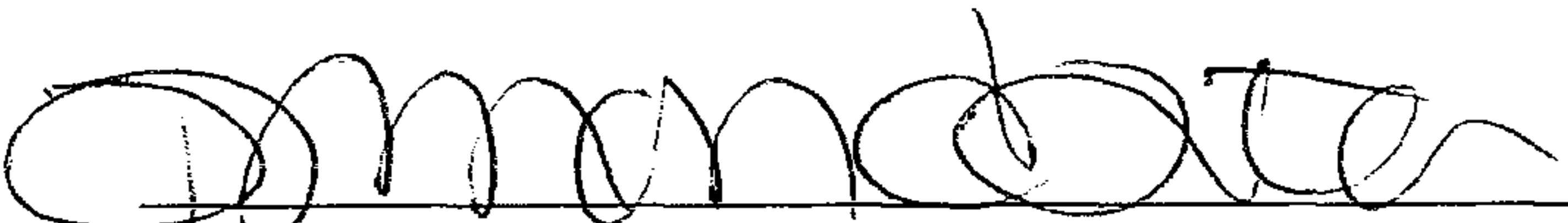

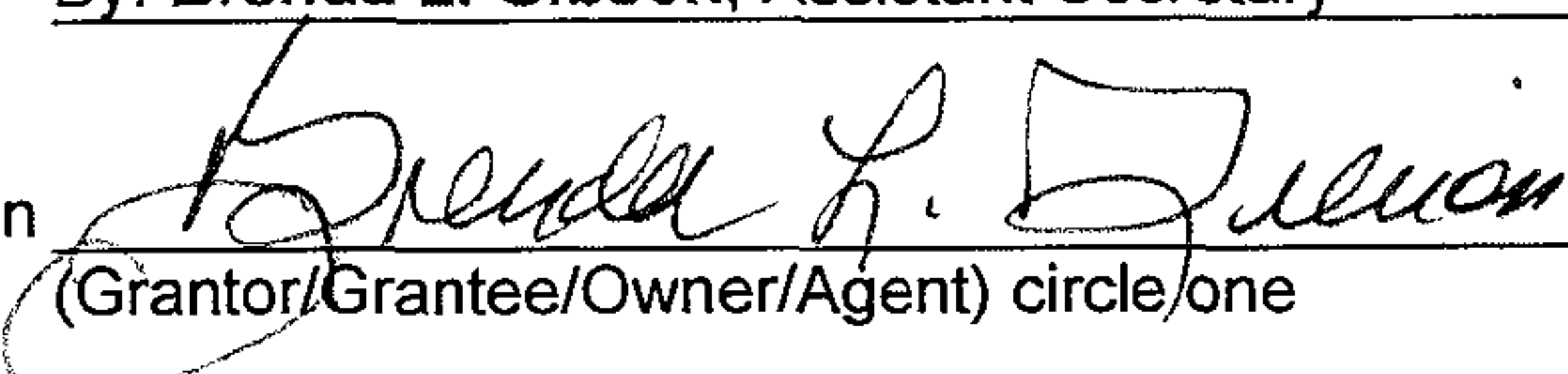
