Unless otherwise delineated, the administrative and/or managerial powers of the trustees shall be governed by the trustees' powers provisions of the laws of the State of Alabama, and the trustees shall be specifically allowed to buy, sell, rent, lease, or otherwise dispose of all trust property, both real and personal.
- 4. Trust Property should be titled as follows: <u>David Franklin Hobson, Trustee of The Hobson Living Trust dated November 24, 2020 and First Amendment thereto dated September 18, 2023, and all further amendments thereto or in the alternative, THE HOBSON LIVING TRUST</u>
- An alternate description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
- 6. The named successor trustee is: LINDSAY ANNE HOBSON, unless she predeceases DAVID FRANKLIN HOBSON. In the event that LINDSAY ANNE HOBSON fails or ceased to serve of Trustee hereunder (due to incapacity, death or resignation,), the Settlor's attorney, DIANA H. - 7. The Trust is Revocable. The person having the power to revoke is the Trustee. To the best of the undersigned's knowledge the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect.
- 8. No person or entity paying money to or delivering property to my Trustee shall be required to see its application. All persons relying on this document regarding the Trustee and his powers over trust property shall be held harmless for any resulting loss or liability from such reliance.
