
**\$216,015.00** of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

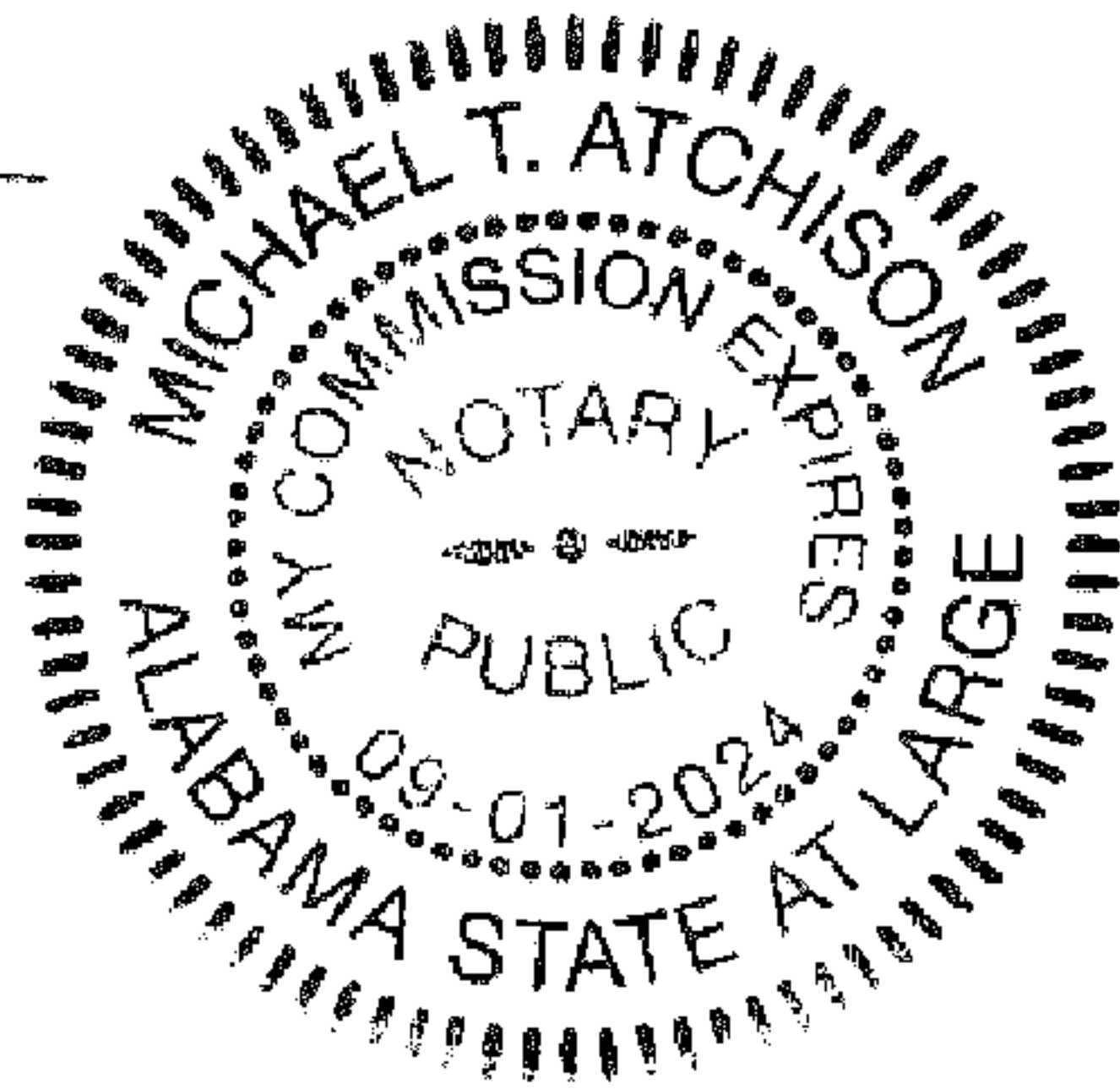
