SAMPLE, JR.**, as Personal Representative of the ESTATE of **DONALD LAFAYETTE SAMPLE, SR.**, Shelby County Probate Case #PR-2024-000002 (hereinafter referred to as Grantor), the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantee, **HAROLD T. WADSWORTH, JR.** (hereinafter referred to as Grantee), the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

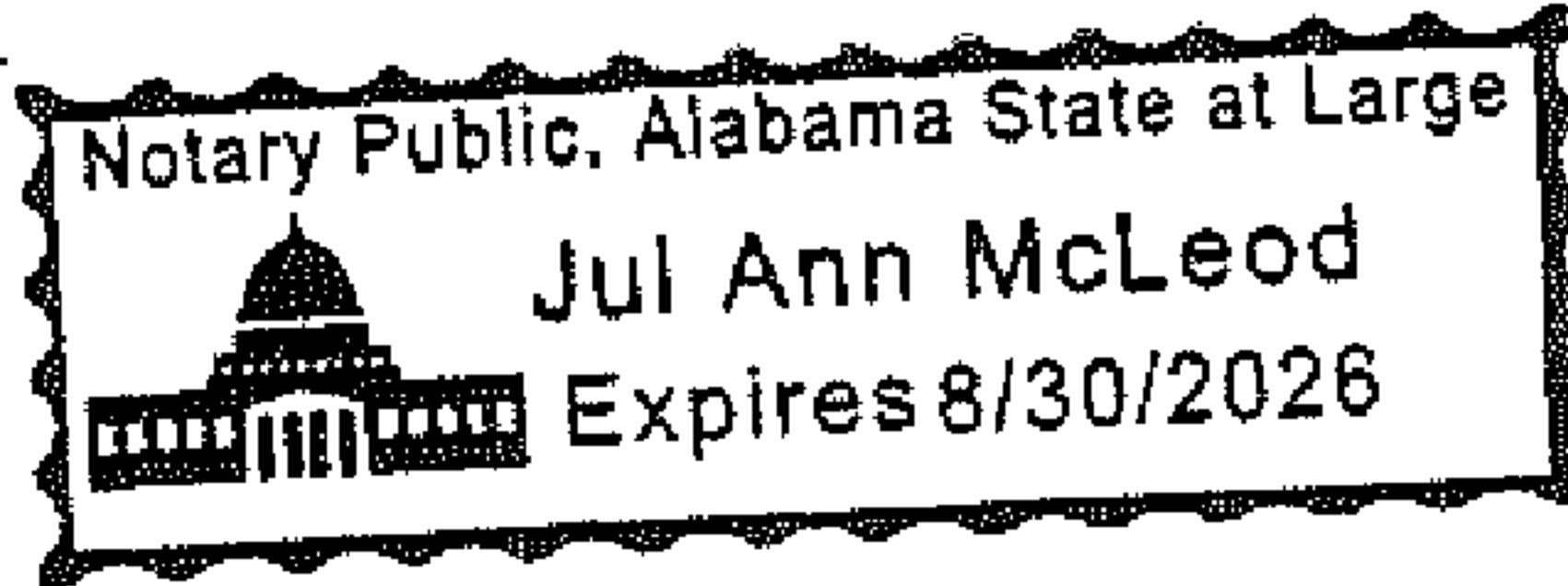
