**CERTIFICATION OF TRUST

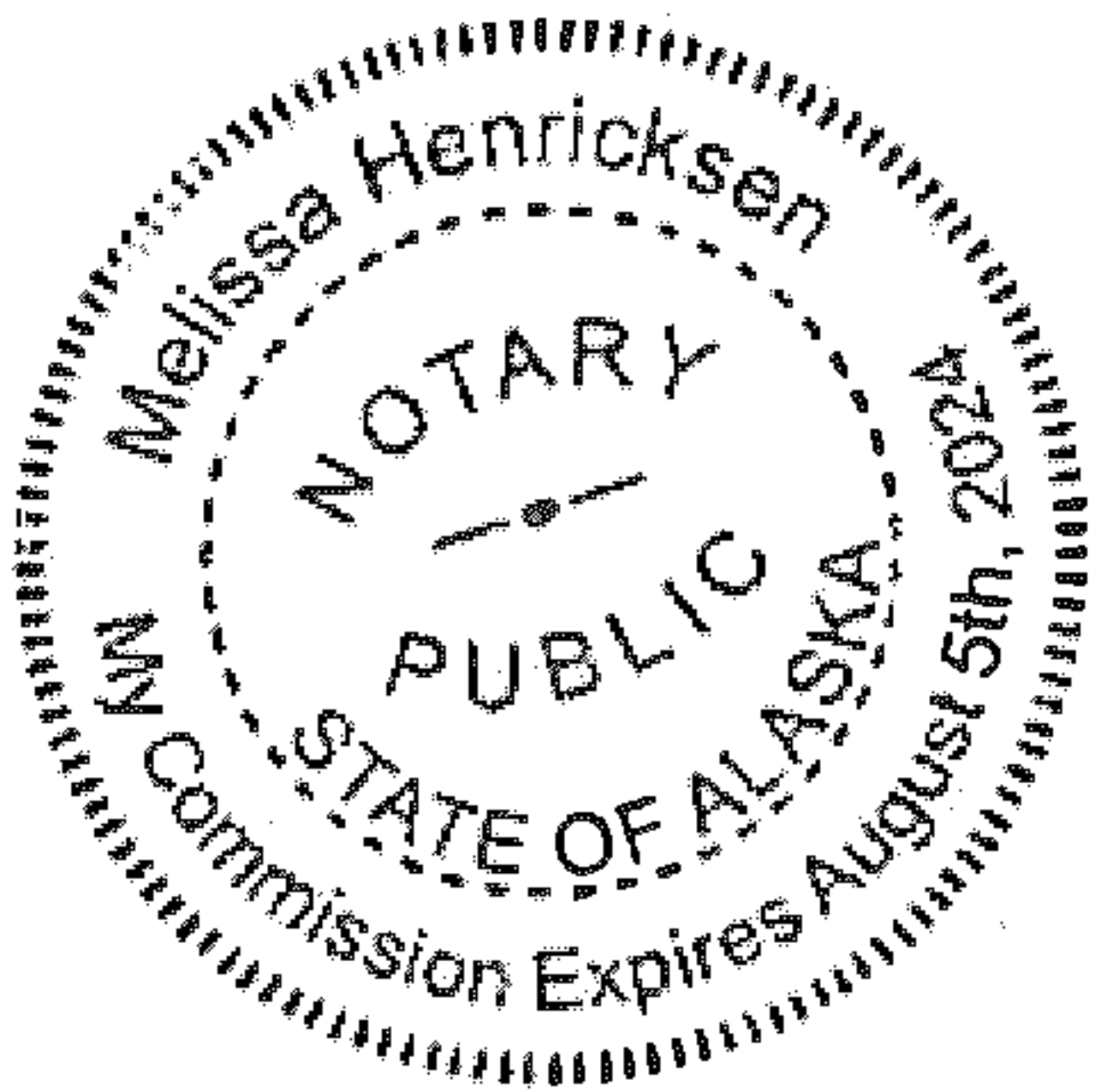
