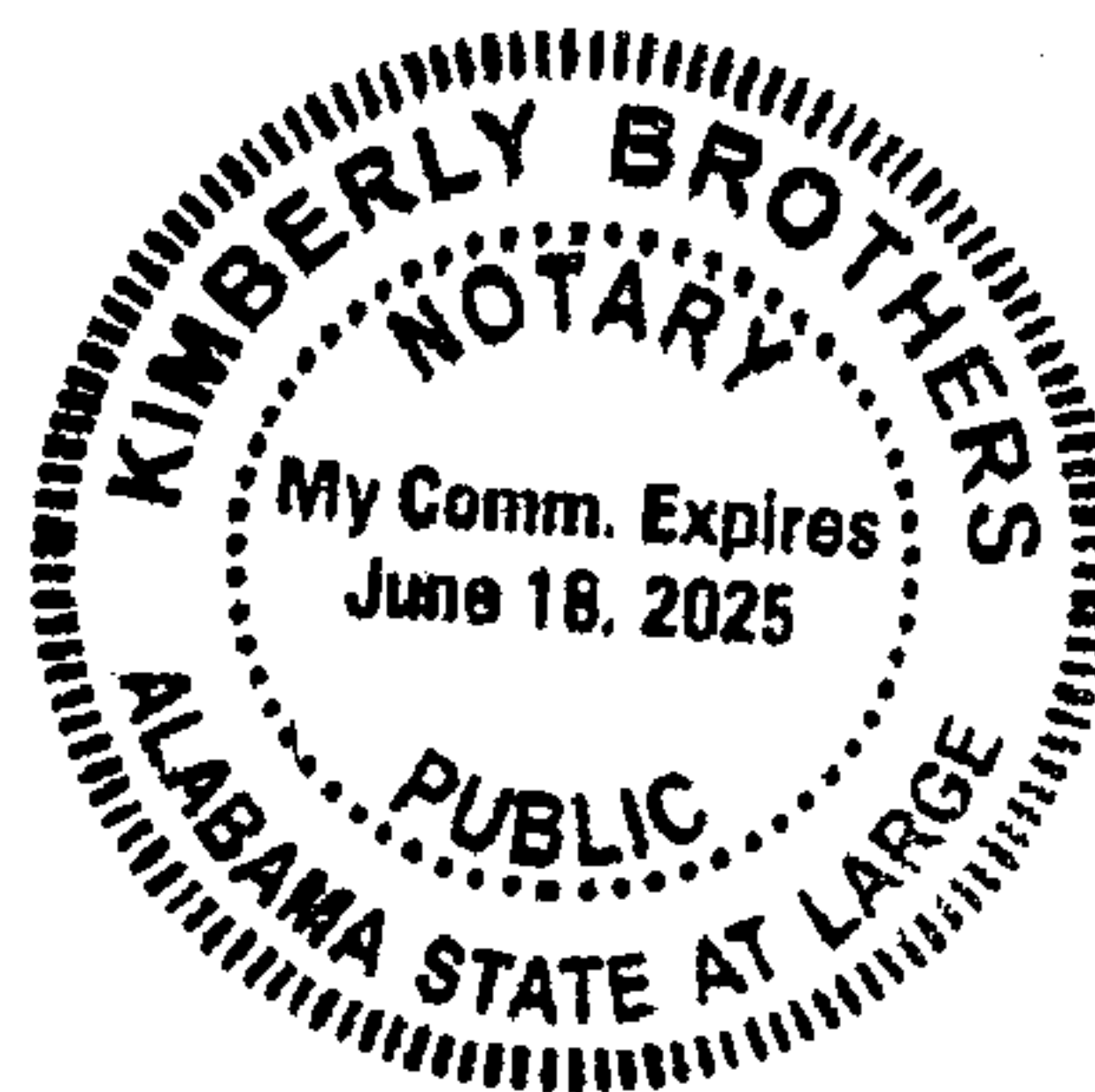

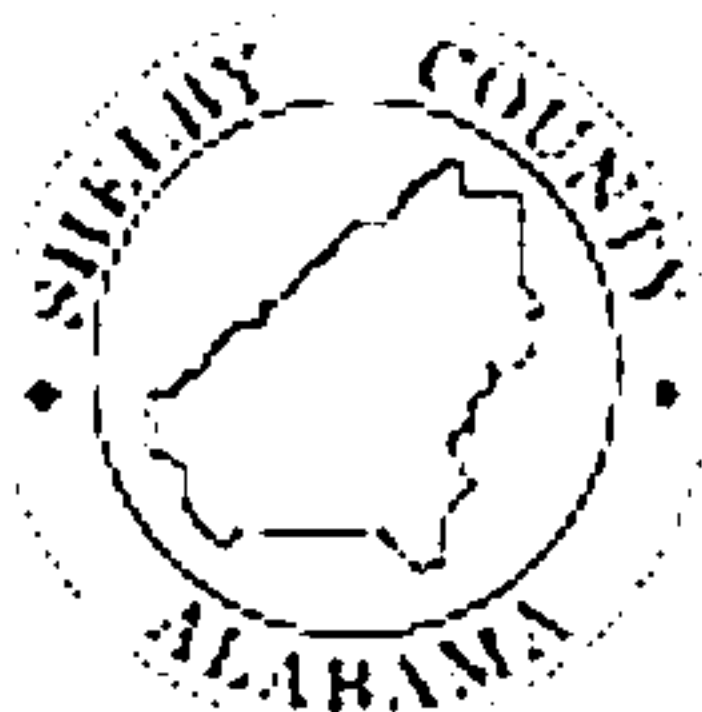
I have knowledge that all heirs named herein are over nineteen (19) years of age and that there are no other heirs of Decedent, including any deceased children or heirs of deceased children.
