Page 71, in the Probate Office of Shelby County, Alabama.

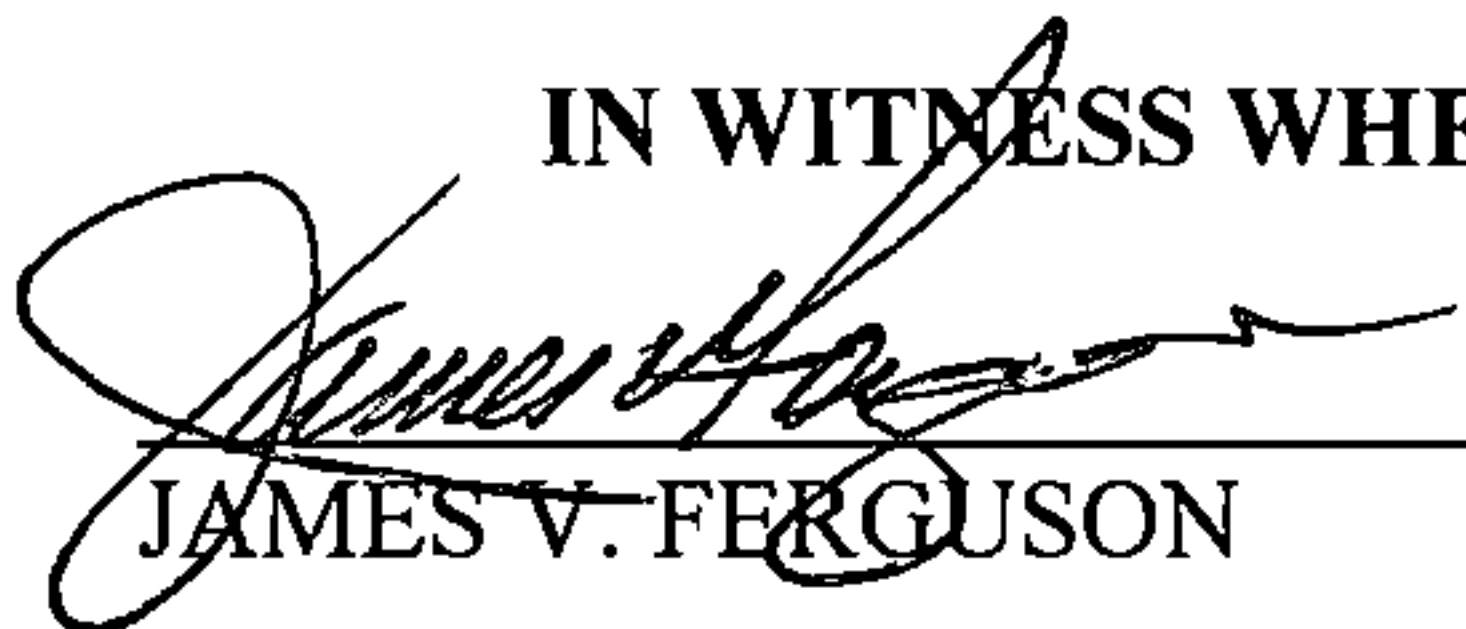

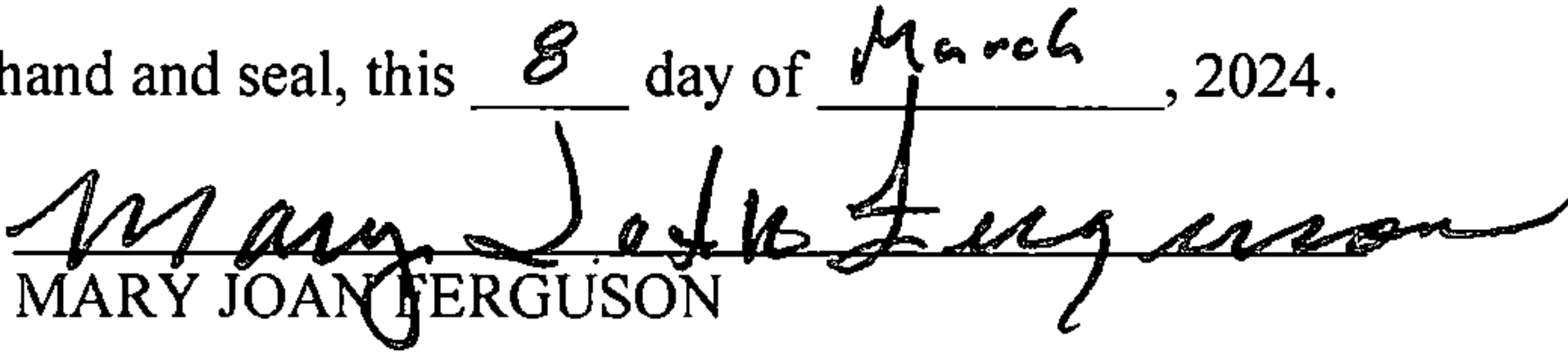
TO HAVE AND TO HOLD to the said grantee, his, her or their successors and assigns forever.

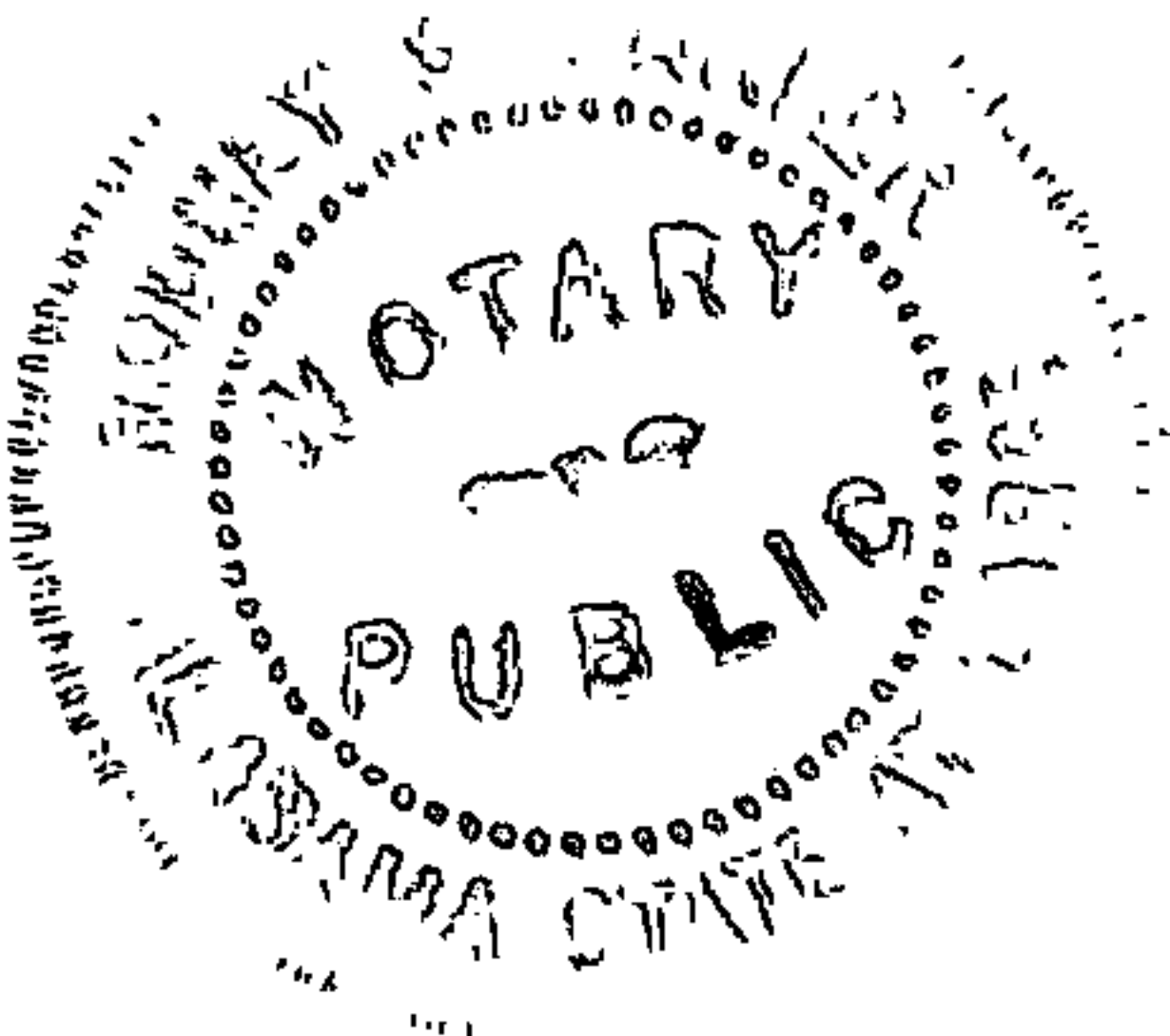
