That in consideration of **Six Hundred Fifty-Nine Thousand Five Hundred and 00/100 Dollars (\$659,500.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

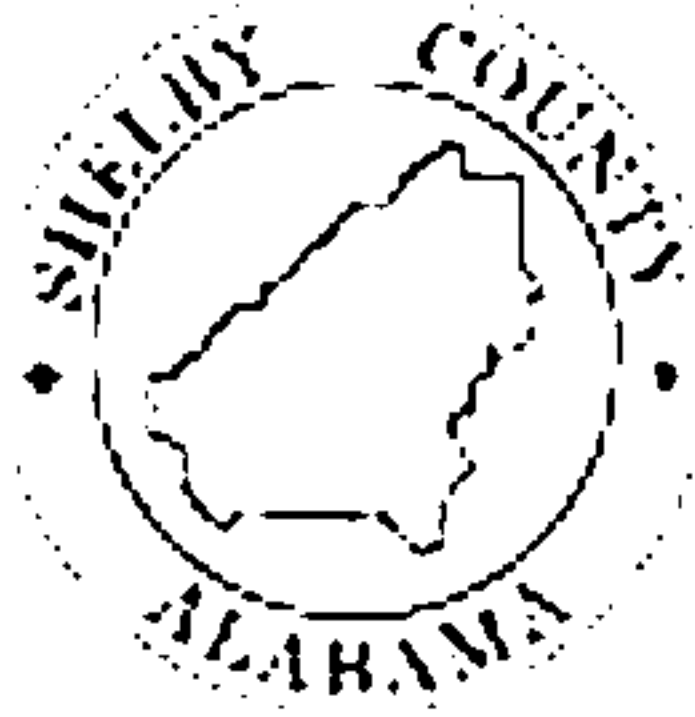
