WARRANTY DEED
Joint Tenancy With Right of Survivorship

KNOW ALL MEN BY THESE PRESENTS, that in consideration of SEVEN HUNDRED FIFTY THOUSAND AND 00/100 DOLLARS (\$750,000.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, John W. Strauss and Heidi Strauss, husband and wife, (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto John Lovoy and Wanda S. Lovoy, husband and wife, (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated Shelby County, Alabama to-wit:

Lot 4108, according to the Survey of Abingdon by The River Phase 2, as recorded in Map Book 53, Page 43, in the Probate Office of Shelby County, Alabama.



Note: \$ 0.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultancously herewith.



And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEES, their heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEES, their heirs, executors and assigns forever, against the lawful claims of all persons.




