Know All Men by These Presents: That in consideration of **Three Hundred Twenty-Three Thousand Five Hundred Seventy and 00/100 Dollars (\$323,570.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH ALABAMA, LLC, a Georgia Limited Liability Company** (herein referred to as Grantor) grant, bargain, sell and convey unto **DOUGLAS L. 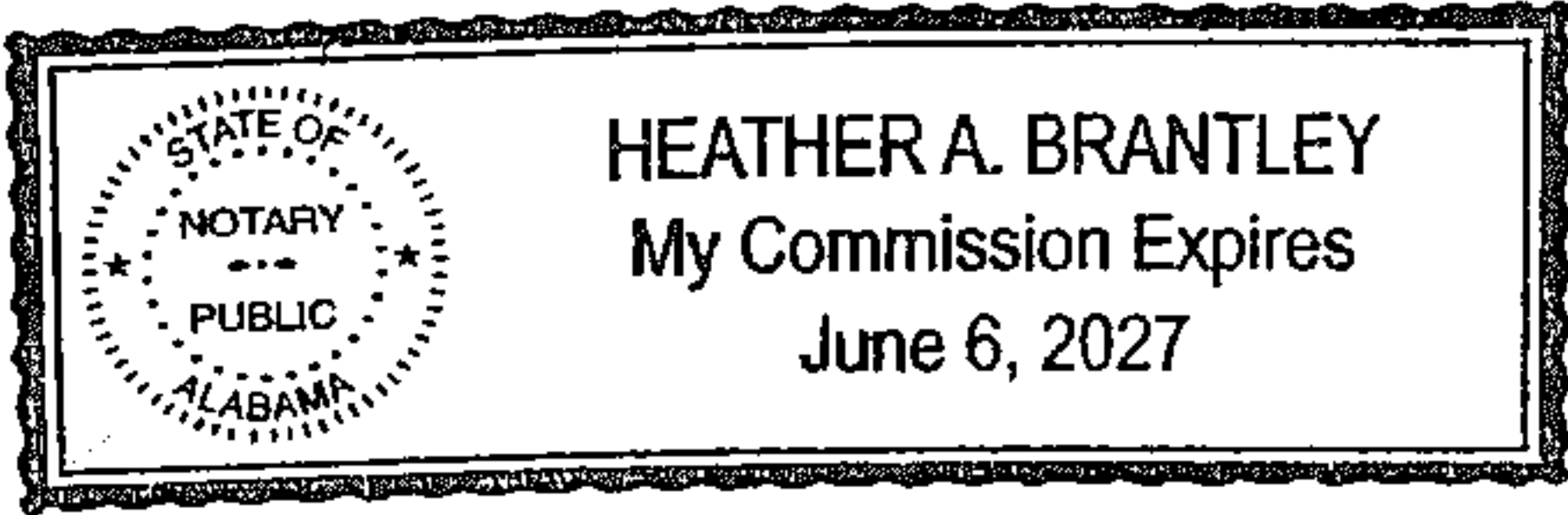
