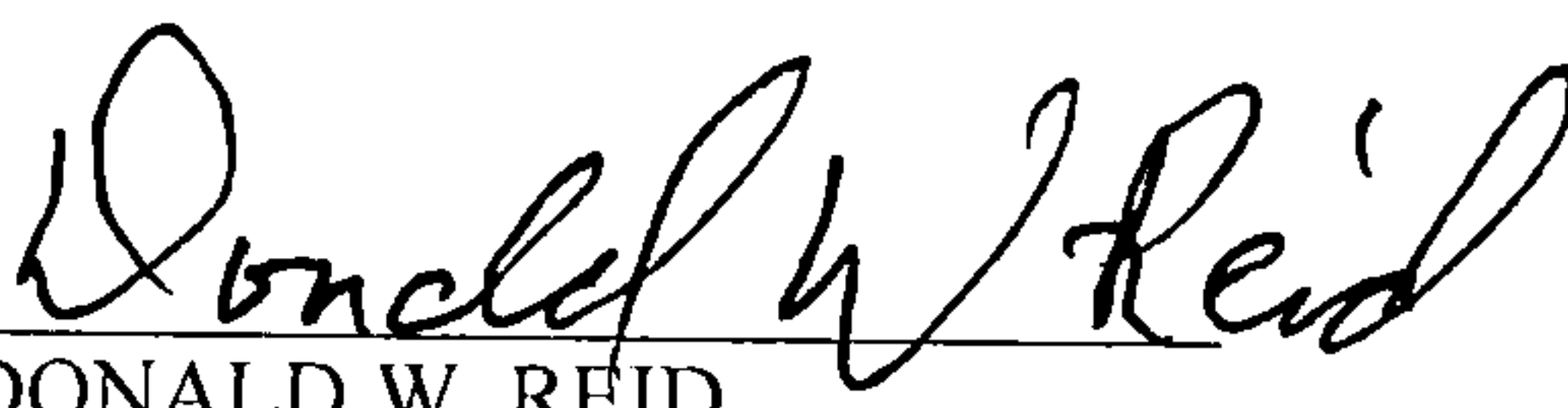

REID JOINT REVOCABLE LIVING TRUST** dated May 1, 2020, and any amendments thereto or in the alternative, the **DONALD W. REID AND REBECCA G. REID JOINT REVOCABLE LIVING TRUST** dated May 1, 2020.

An alternate description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.

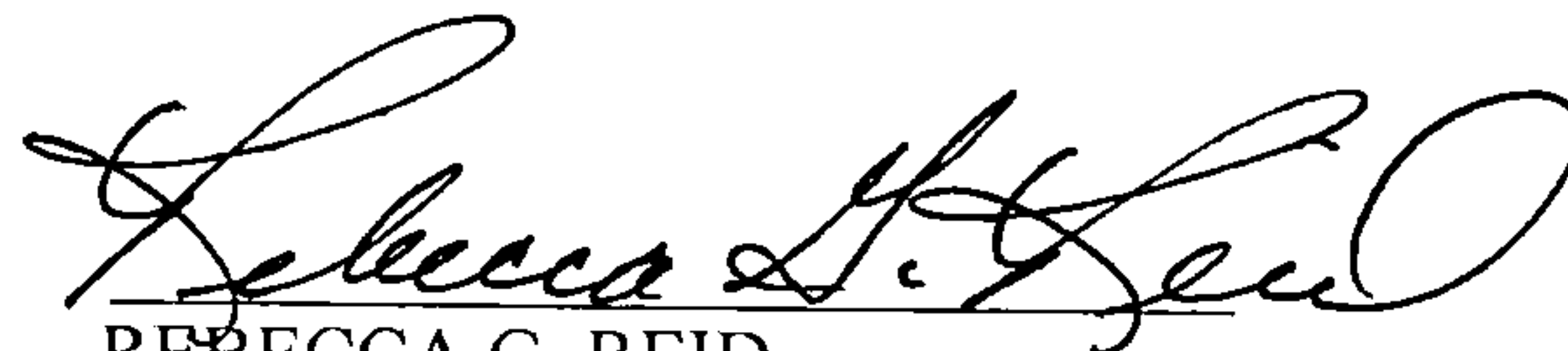

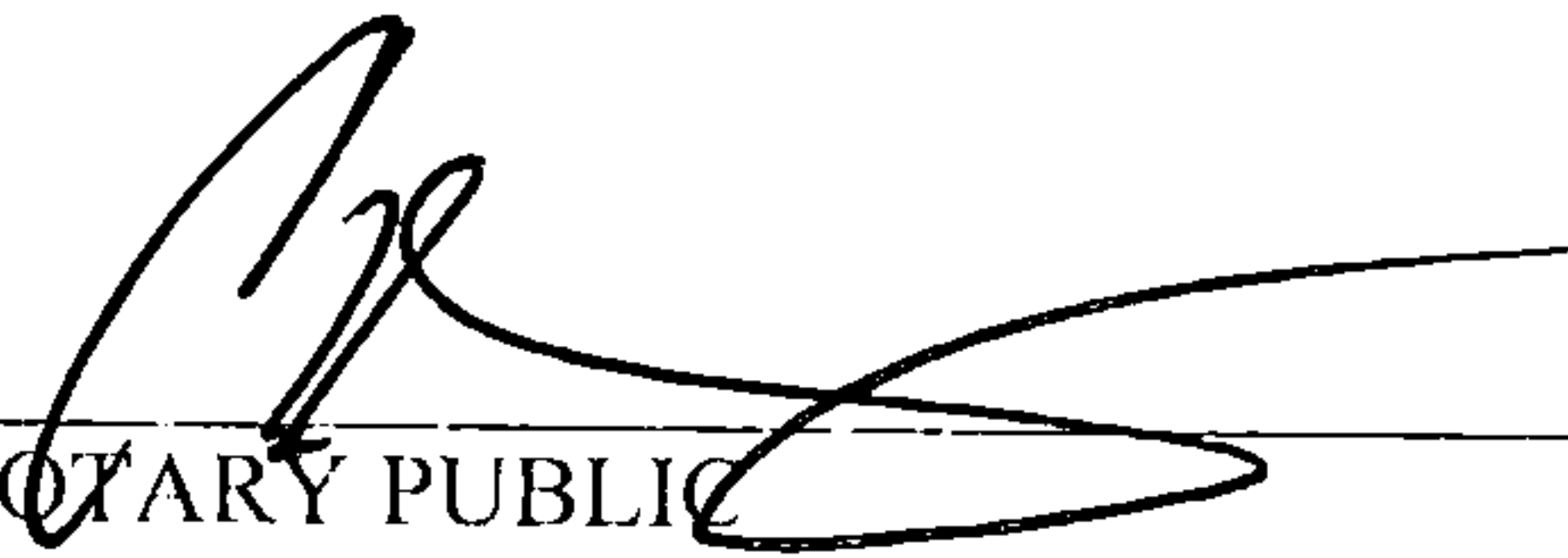
