WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

SHELBY COUNTY KNOW ALL MEN BY THESE PRESENTS

That in consideration of **THREE HUNDRED FORTY NINE THOUSAND AND 00/100 Dollars (\$349,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

Scott L. Brown and Kim R. Thomas, husband and wife

(hereinafter referred to as “Grantors”) do grant, bargain, sell and convey unto

William Edward Krieger, Jr. and Sarah Goodwin

(hereinafter referred to as “Grantees”), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:


\$279,200.00 of the proceeds come from a mortgage recorded simultaneously herewith.


- Subject to:




