That in consideration of **TWO HUNDRED SEVENTY FIVE THOUSAND AND 00/100 Dollars (\$275,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, **Karlee White a/k/a Karlee Gilliam, and Jordan White, Wife and Husband** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Micah Scarborough and Erica Devyn Scarborough** (herein referred to as grantees), as joint tenants with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**, to-wit:

Subject to:

3. **\$270,019.00** of the consideration herein was paid from the proceeds of a mortgage filed simultaneously herewith.

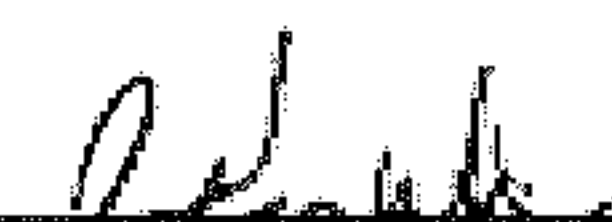

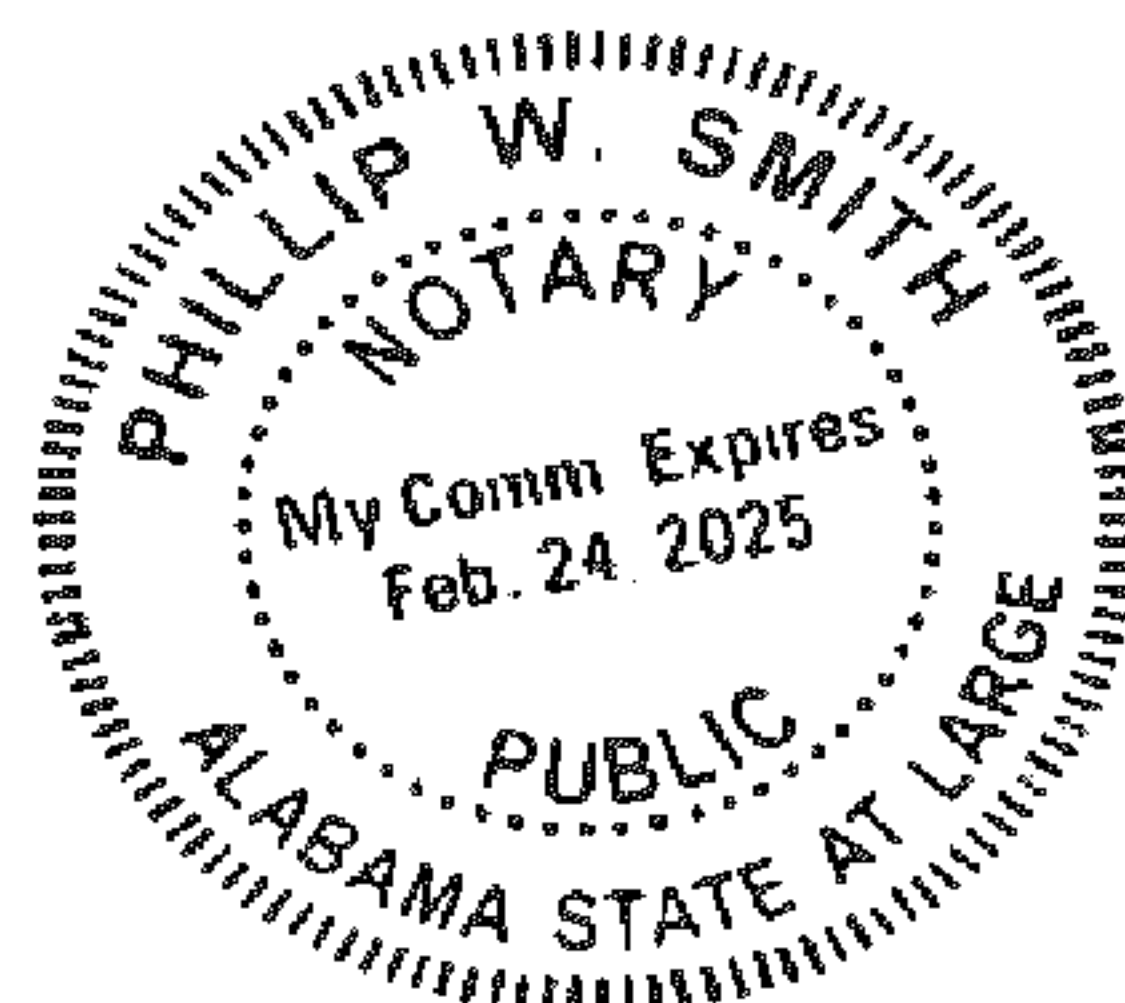
