That in consideration of **Two Hundred Eighty-Four Thousand Nine Hundred and 00/100 (\$284,900.00) Dollars** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Haley Miranda Frost (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **Shelby** County, Alabama, to-wit:

Lot 77, Chelsea Acres Sector 1 Phase 1B, a map or plat of which is recorded in Map Book 58, Page 16 in the Probate Office of Shelby County, Alabama.

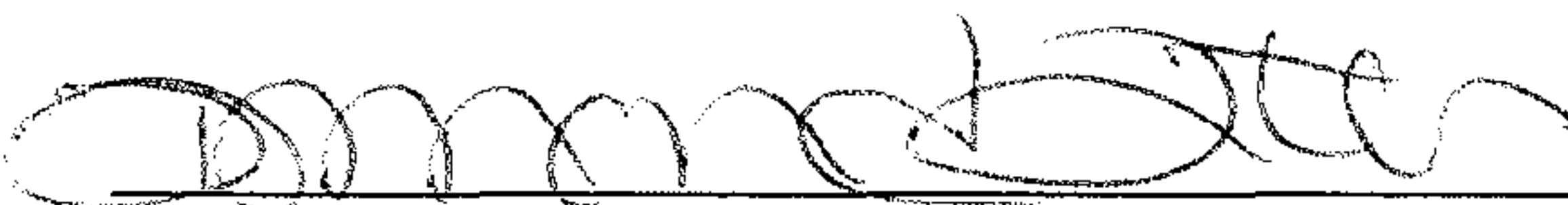
