FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, August 1, 2013, Shari Williams, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Acopia, LLC, which said mortgage was recorded in Instrument No. 20130805000317780 and modified in Instrument No. 20220602000222790 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to U.S. Bank Trust National Association, not in its individual capacity, but solely as Owner Trustee for Citigroup Mortgage Loan Trust 2023-A by instrument recorded in Instrument Number 20231208000355000 in the aforesaid Probate Office Transferee and




