That in consideration of **THREE HUNDRED FIVE THOUSAND AND 00/100 Dollars (\$305,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

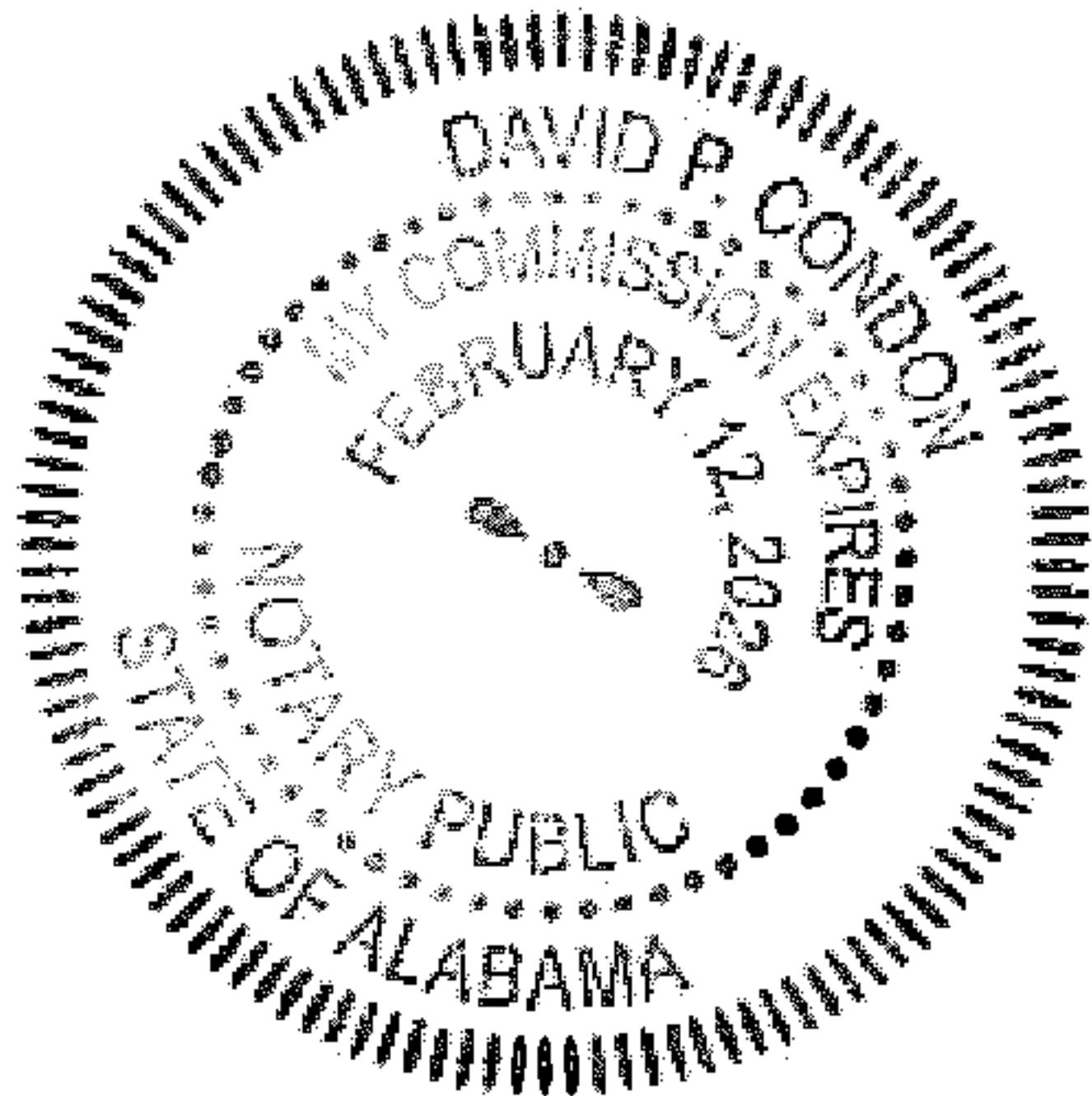

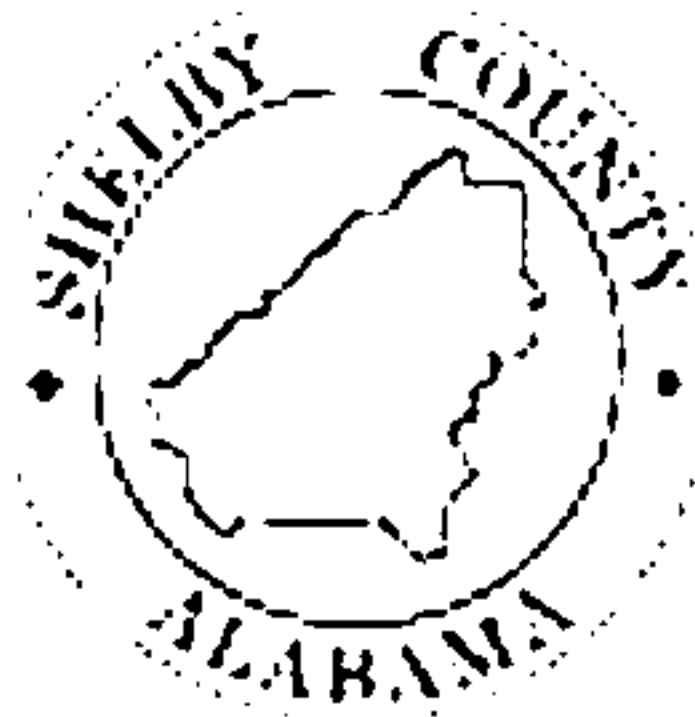
