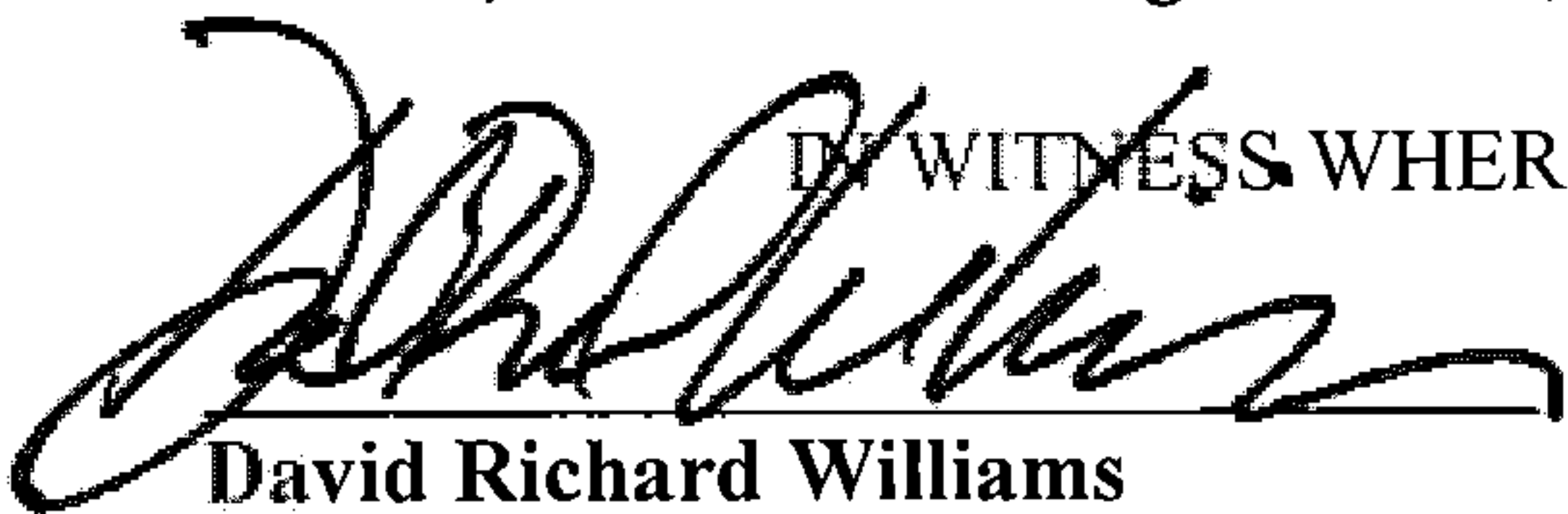
The property described above and conveyed herein is no longer the homestead of the grantor or his spouse.

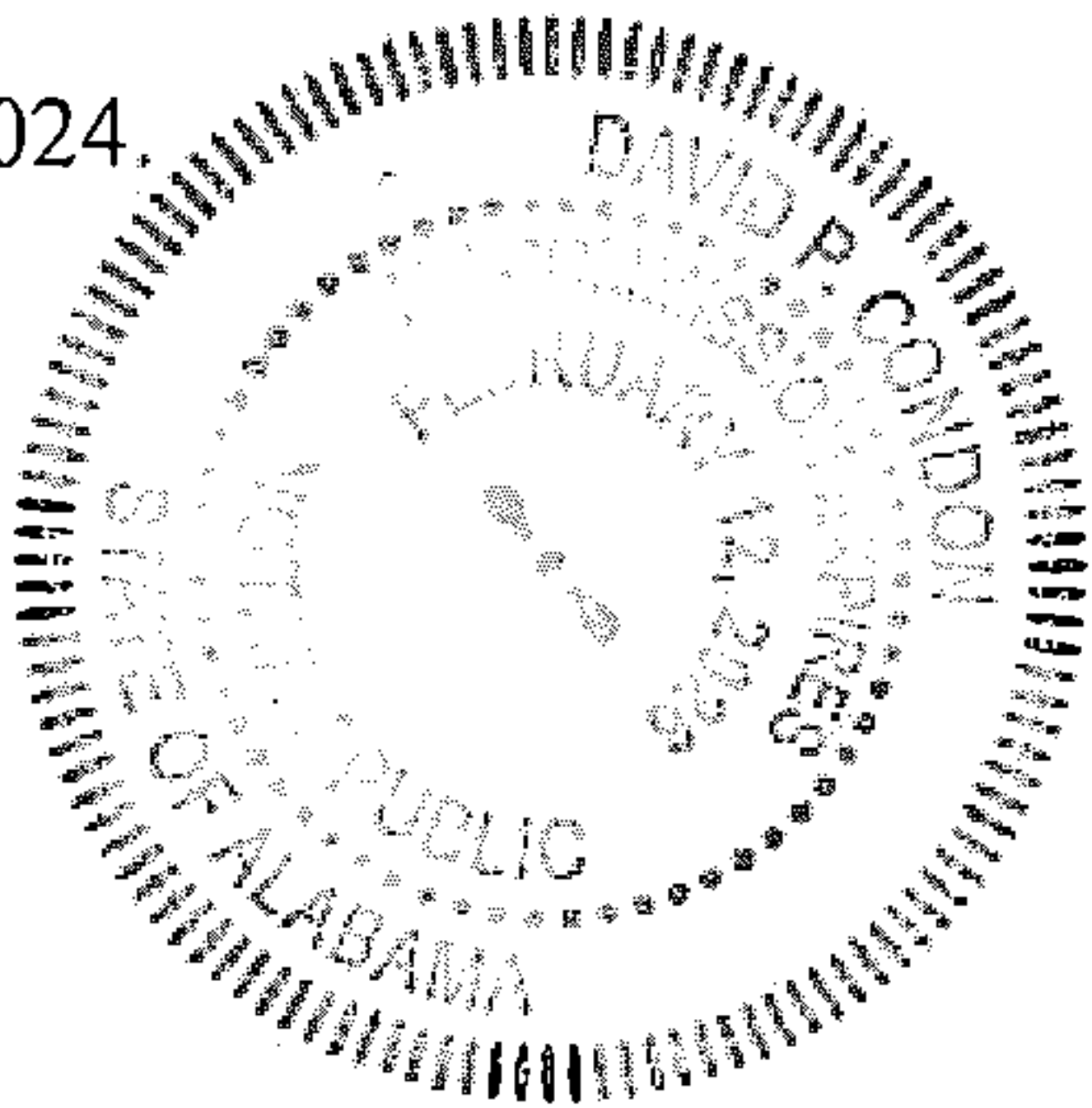
