Knew all men by these presents, that in consideration of Ten Thousand One Hundred Fifty-Five Dollars and 00/100 (\$10,155.00) and other good and valuable consideration, the receipt of sufficiency of which are hereby acknowledged, that **Nancy J. Young, a widow; Layne D. Young, and Tiffany Young, a married couple, and Donald C. Young, a married man**, hereinafter known as GRANTOR, does hereby bargain, grant, sell and convey the following described real property being situated in Shelby County, Alabama, to **Nancy J. Young** hereinafter known as the GRANTEE:

PARCEL 1: Beginning at an old rebar at the northeast corner of the west half of the northwest quarter of the southeast quarter of said Section 22. Thence South along a fence the east line of the west half of the northwest quarter of the Southeast quarter of said section a distance of 356.99 feet to a point; Thence turn a deflection angle of 66 degrees 21' 00" to the right and run a distance of 185.66 feet to an iron; Thence turn a deflection angle of 90 degrees 00' 00" to the right and run a distance of 348.50 feet to an iron; Thence turn a deflection angle of 90 degrees 00' 00" to the left and run a distance of 250.00 feet to an iron on the east right-of-way of North Horton Road. Thence turn a deflection angle of 90 degrees 00' 00" to the right and run along said right-of-way a distance of 75.96 feet to an iron; Thence turn a deflection angle of 79 degrees 33' 22" to the right and run a distance of 587 feet to the Point of Beginning. The herein described parcel contains 2.45 acres of land. The description was made from a survey by L. D. Weygand. 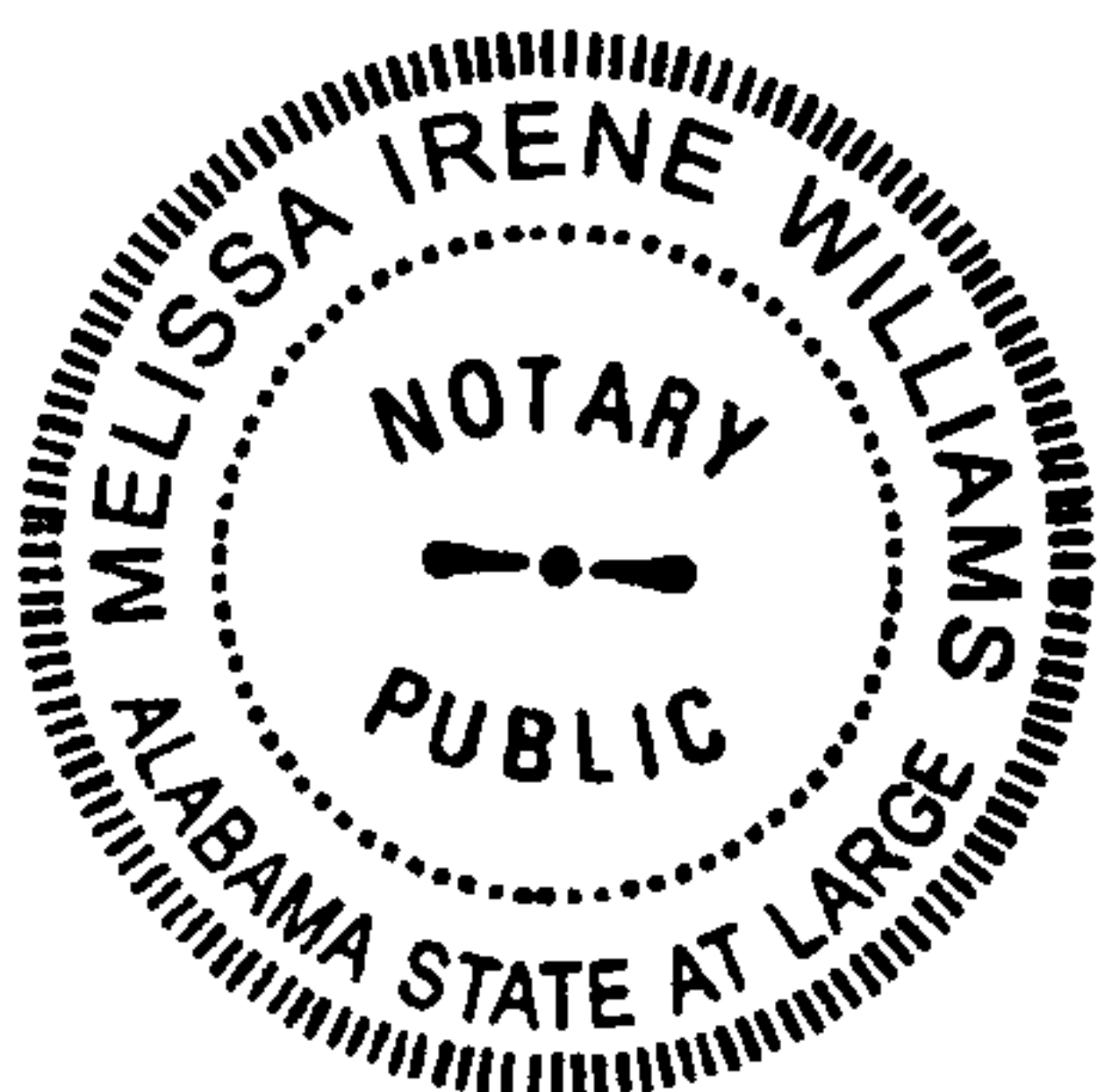

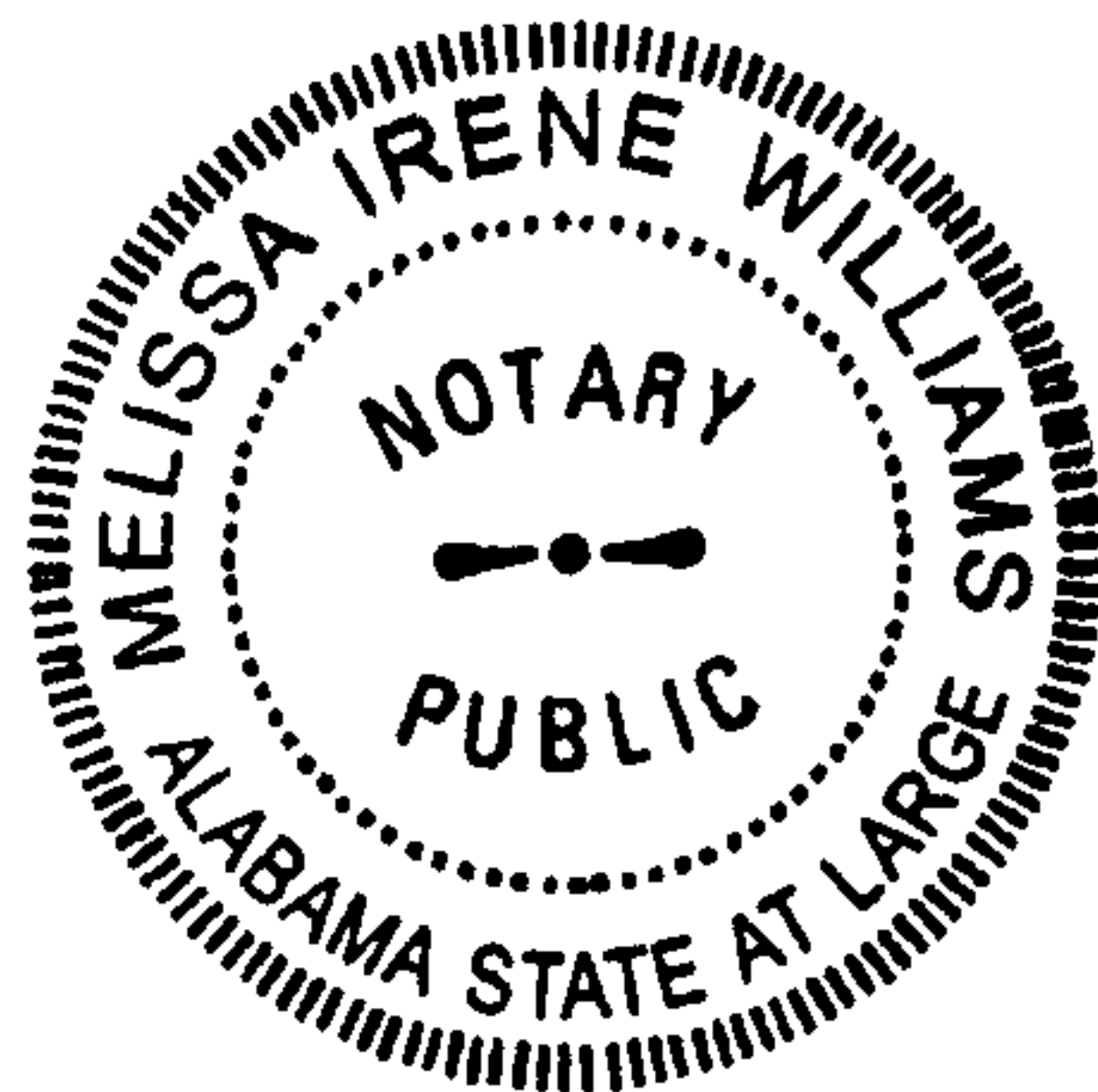
