WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **SEVEN HUNDRED FIFTY THOUSAND AND 00/100 Dollars (\$750,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

**Richard F. Herring and Kimberly A. Herring, husband and wife**

(hereinafter referred to as “Grantors”) do grant, bargain, sell and convey unto

**Claude E. Wood, IV and Ashley Wood**

(hereinafter referred to as “Grantees”), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:


**Lot 2-17 according to the plat of The View at Indian Crest Phase 2, as recoded at Map Book 57, Page 76 A & B, in the Probate Office of Shelby County, Alabama.**


- Subject to:

And we do for ourselves and for our heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.



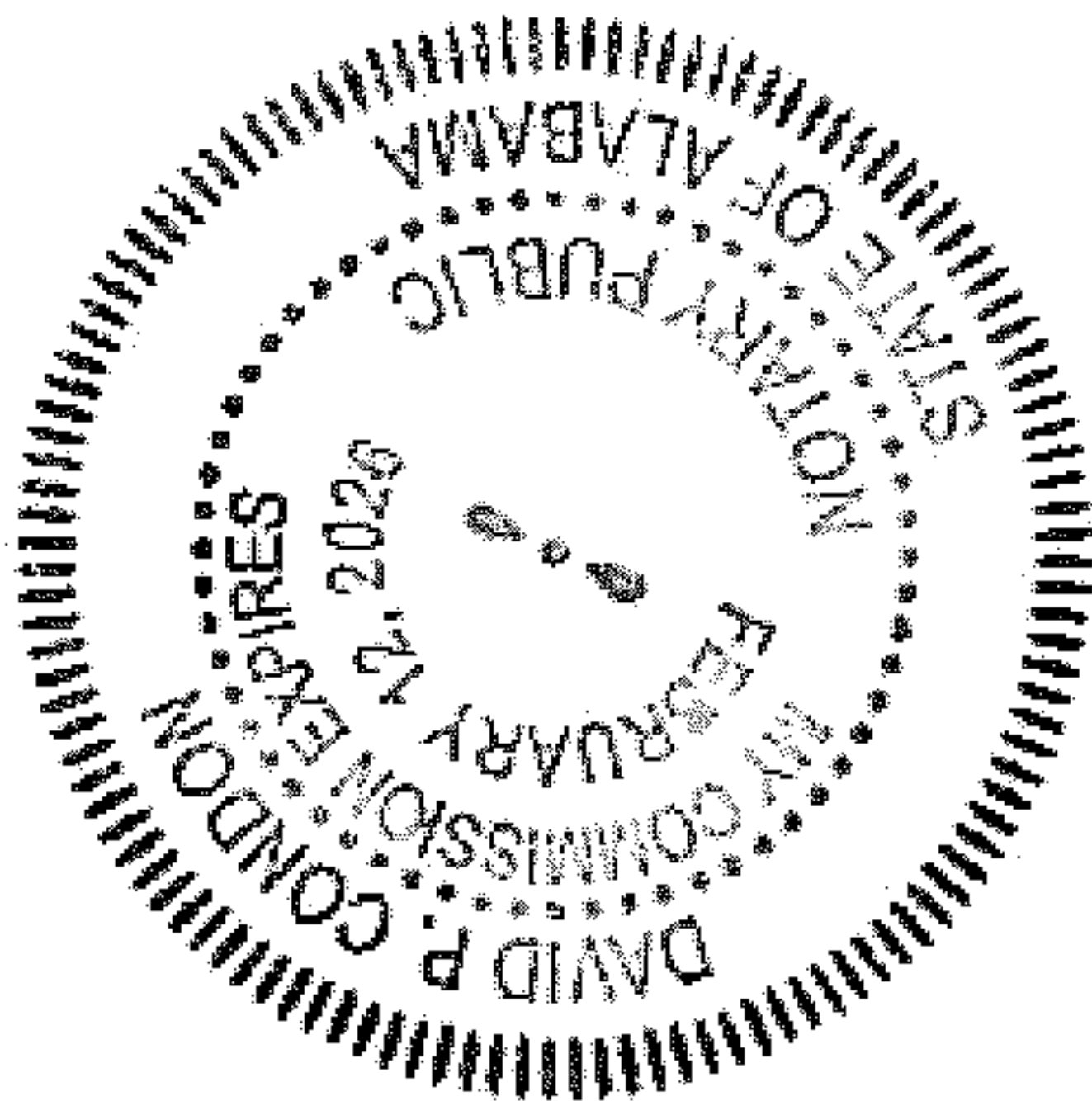


