} Know All Men by These Presents:

County of Shelby

That in consideration of the sum of **Two Hundred Eighty Five Thousand Dollars and No Cents (\$285,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Trenton Grubbs**, a single man (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Kevin Dermody and Laurie Dermody**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 6, according to the Map of Plat of Fadora II, as recorded in Map Book 40, Page 29, in the Probate Office of Shelby County, Alabama.

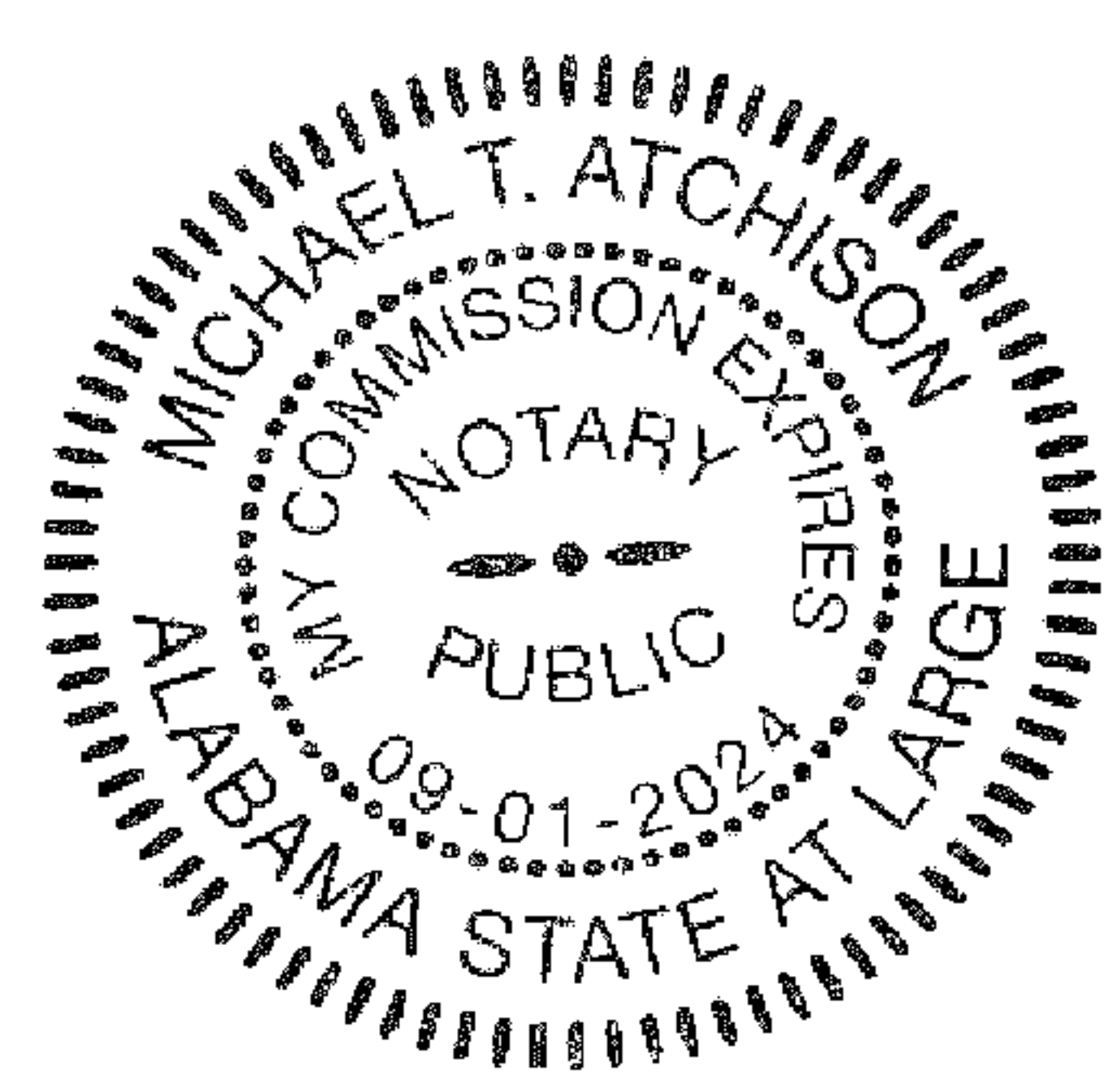
