That in consideration of **Three Hundred Forty-Four Thousand Nine Hundred and 00/100 (\$344,900.00) Dollars** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Danielle Monique Moore (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **Shelby County, Alabama**, to-wit:

Lot 2371, Chelsea Park 23rd Sector, 1st Phase, a map or plat of which is recorded in Map Book 58, Pages 64A, 64B and 64C, in the Office of the Judge of Probate, Shelby County, Alabama.

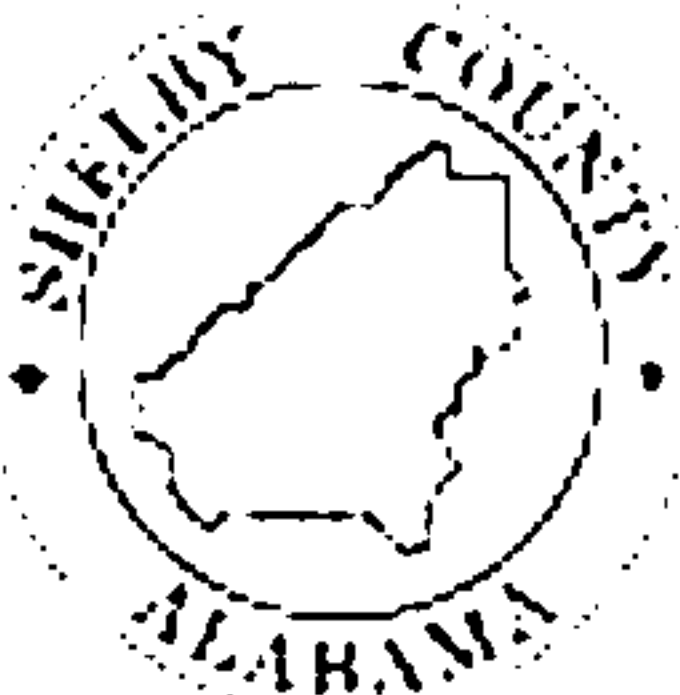
