FURTHER, pursuant to Section 9.4(b) of the Trust, I, as co-Trustee, hereby make, constitute and appoint JOHN WILLIAM COLE, as special co-Trustee, my true and lawful delegate, to do, execute and perform any act, deed, matter or thing whatsoever that ought to be done, executed or performed, or in the opinion of the delegate ought to be done, executed or performed with respect to and in conjunction with the performance of my duty as co-Trustee of the Trust for all property held by the Trust in the State of Alabama, as fully and effectively as if I were personally present; and to execute in my name, seal and deliver any and all instruments in writing deemed advisable to carry out any of these powers, and no one dealing with the delegate need inquire into the validity of anything the delegate does or need see to the application of any money paid or any property transferred to or upon the order of the delegate. This delegation of authority shall be effective as of the date hereof and shall remain effective until revoked in writing by me.
