# Power of Attorney

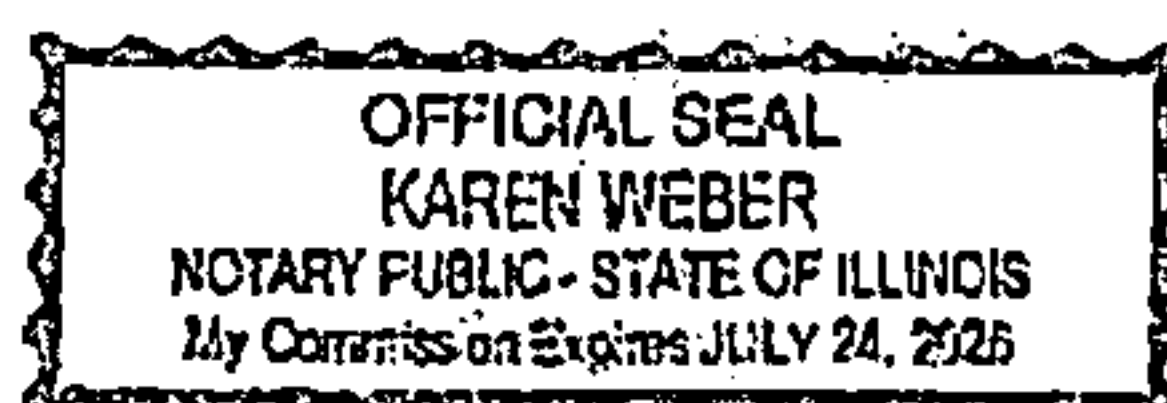
