FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, December 13, 2018, Finley Anne Reneau and Marshall Scott Reneau II, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for HomeBridge Financial Services, Inc. its successors and assigns, which said mortgage was recorded in Instrument Number 20181214000437840 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to Flagstar Bank, N.A. by instrument recorded in Instrument No. 20211210000586360 in the aforesaid Probate Office (hereafter "Transferee"); and

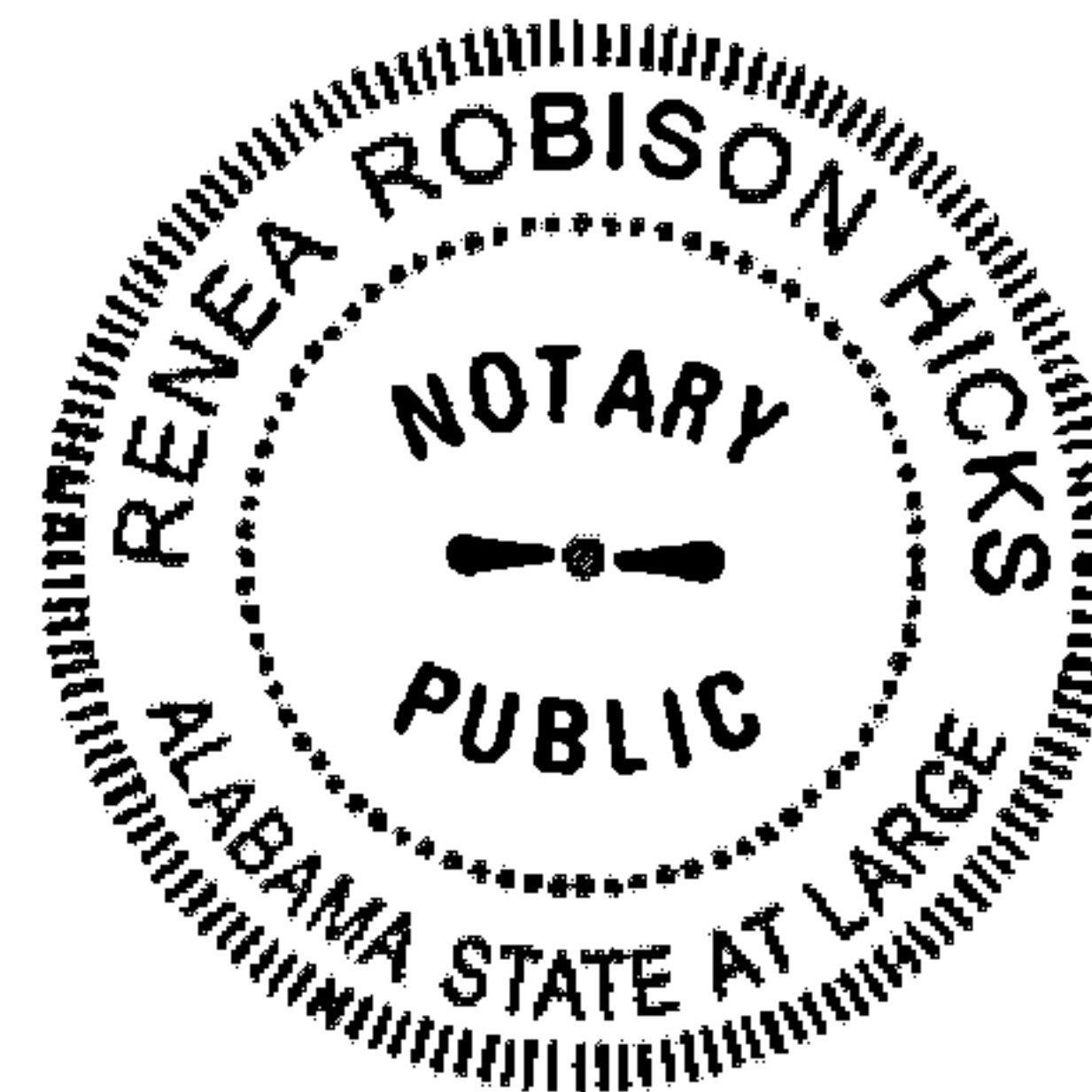

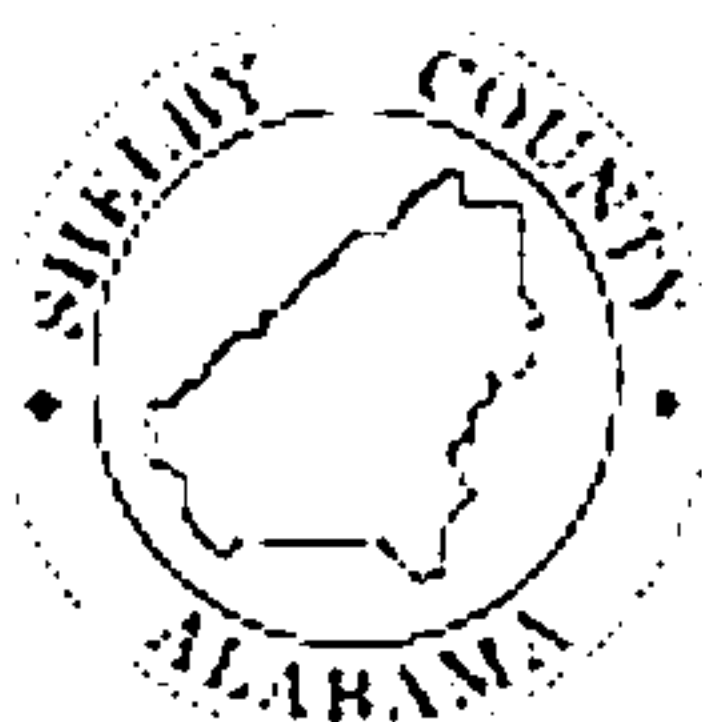
