The undersigned Trustee hereby certifies the following:

- 1, This Certificate of Trust refers to the PEARL W. MONTALBANO TRUST DATED NOVEMBER 19, 2021 executed by Pearl W. Montalbano, as Grantor and Trustee.
2. The initial Trustee of the Trust was: Pearl W. Montalbano.
3. Pearl W. Montalbano created that certain revocable trust agreement on August 9, 2001 as a resident of the State of Alabama and on November 19, 2021 as provided for in that trust, as Grantor and Trustee of the 2001 Trust, Pearl W. Montalbano entered into the 2021 Restatement in its entirety of the 2001 Trust on November 19, 2021, hereinafter referred to as the Montalbano Trust dated 11/19/21 or the Trust.
4. Pearl W. Montalbano served as trustee of Montalbano Trust dated 11/19/21 from its original inception of August 9, 2001 to her death on August 22, 2023. The Montalbano Trust dated 11/19/21 provided that in the event of the death of Pearl W. Montalbano while serving as trustee, that her son, Jerry J. Montalbano shall serve as Successor Trustee upon this event.
5. The Trust was revocable by the Grantor during her lifetime and became irrevocable at her death.
6. On August 30, 2023, Jerry J. Montalbano, Successor Trustee accepted his appointment as Successor Trustee of said Trust with all the power, duties, authorities and liabilities as such Trustee and agreed to receive, accept and hold the Trust and its assets transferred to him pursuant to the terms of the Montalbano Trust dated 11/19/21 by written document and Jerry J. Montalbano is presently serving as Trustee.

The trust became irrevocable on August 22, 2023, the Grantor's date of death, has not been amended or modified in any manner that would cause the representations contained in this certification of trust to be incorrect subsequent to its date of Restatement on November 19, 2021 and has not been terminated by its terms.

7. The trustee under the trust agreement is authorized to acquire, sell, convey, encumber, lease, borrow, manage and otherwise deal with interests in real and personal property in the trust's name. All powers of the trustee are set forth in the Duties and Powers clause and under applicable state law in the trust agreement. A copy of said clause is available upon request.

8. A copy of this Certificate of Trust shall be just as valid as the original.

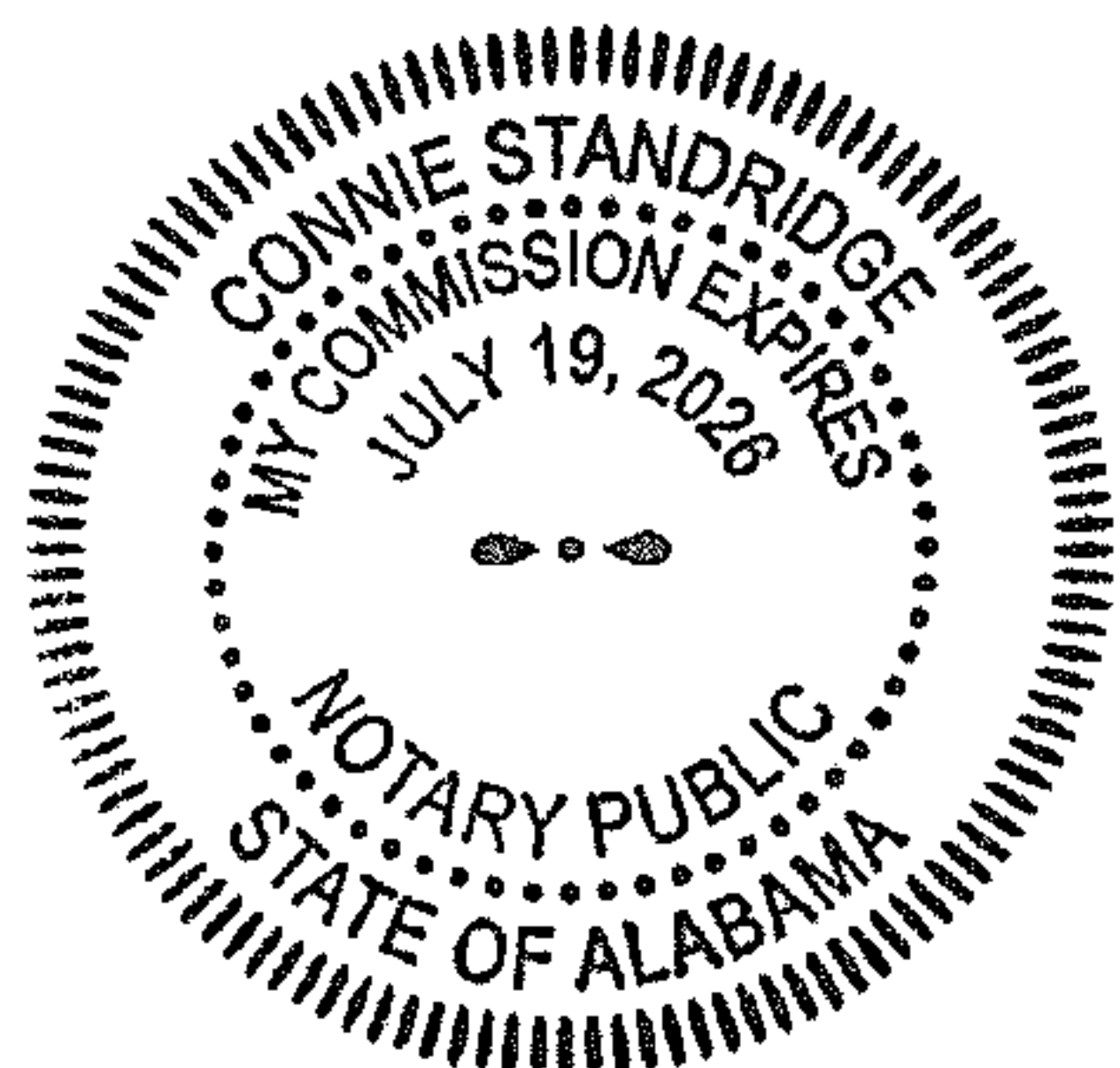
