
IN THE SMALL CLAIMS COURT OF SHELBY COUNTY, ALABAMA

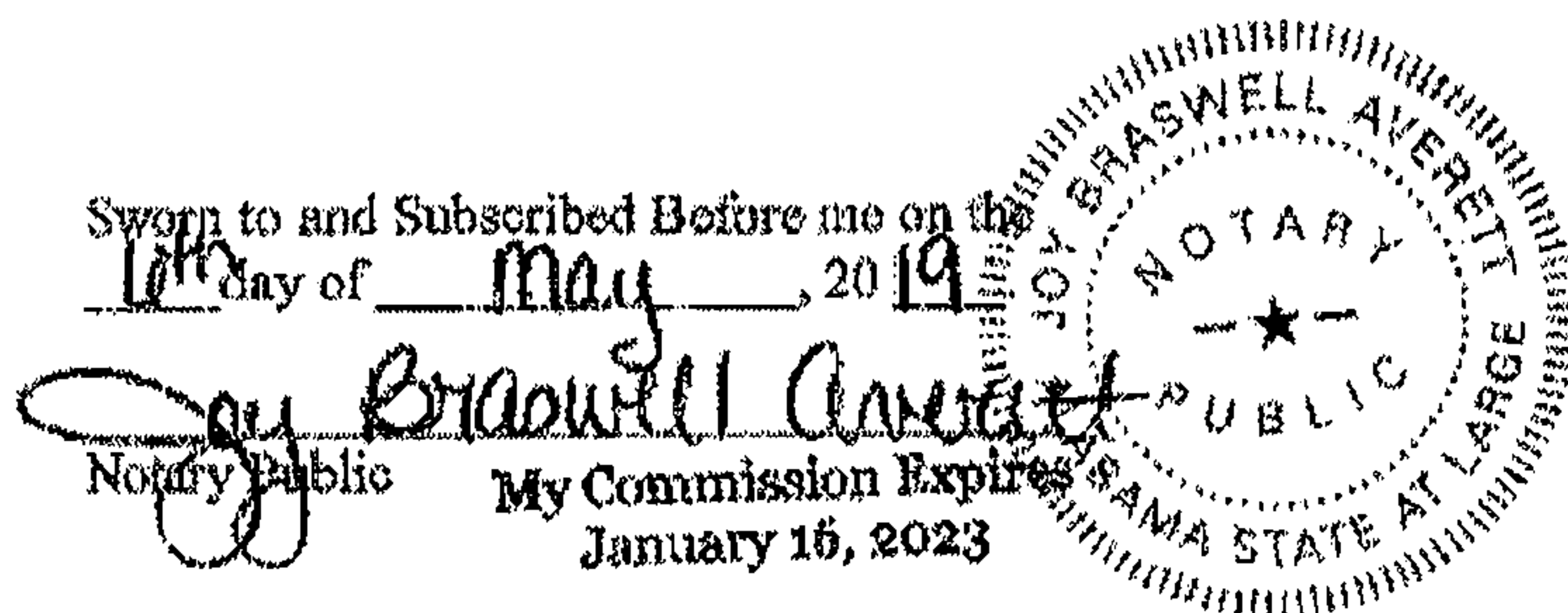
The affiant, being duly sworn, states as follows:
