
The affiant, being duly sworn, states as follows:

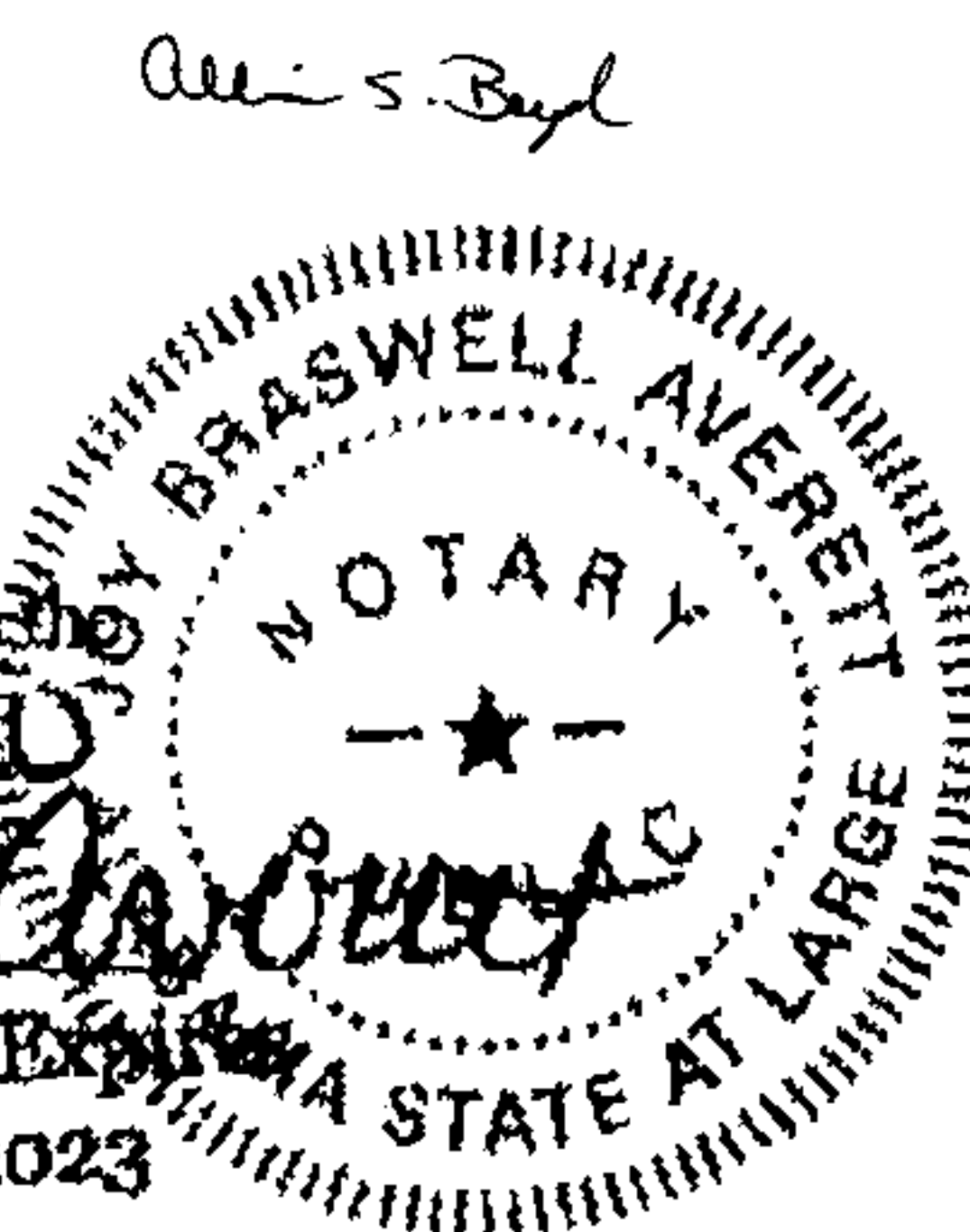
