Power of Attorney

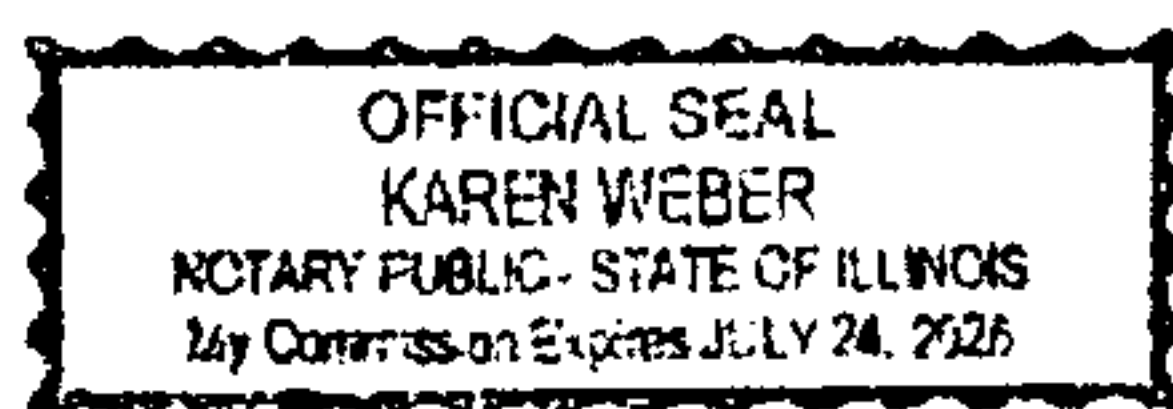


