**KNOW ALL MEN BY THESE PRESENTS:** That in consideration of **Two Hundred Thirty-Five Thousand and No/100 Dollars (\$235,000.00)** and other good and valuable consideration, to the undersigned grantor, in hand paid by the grantees herein, the receipt where is acknowledged I, **Anna Marie Sparks, an unmarried person** (herein referred to as grantor), grant, bargain, sell and convey unto **Therese Bouvier O'Rourke and Jeremiah A. O'Rourke** (herein referred to as grantees) for and during their joint lives, and upon death of any of them, then to the survivor(s) of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:

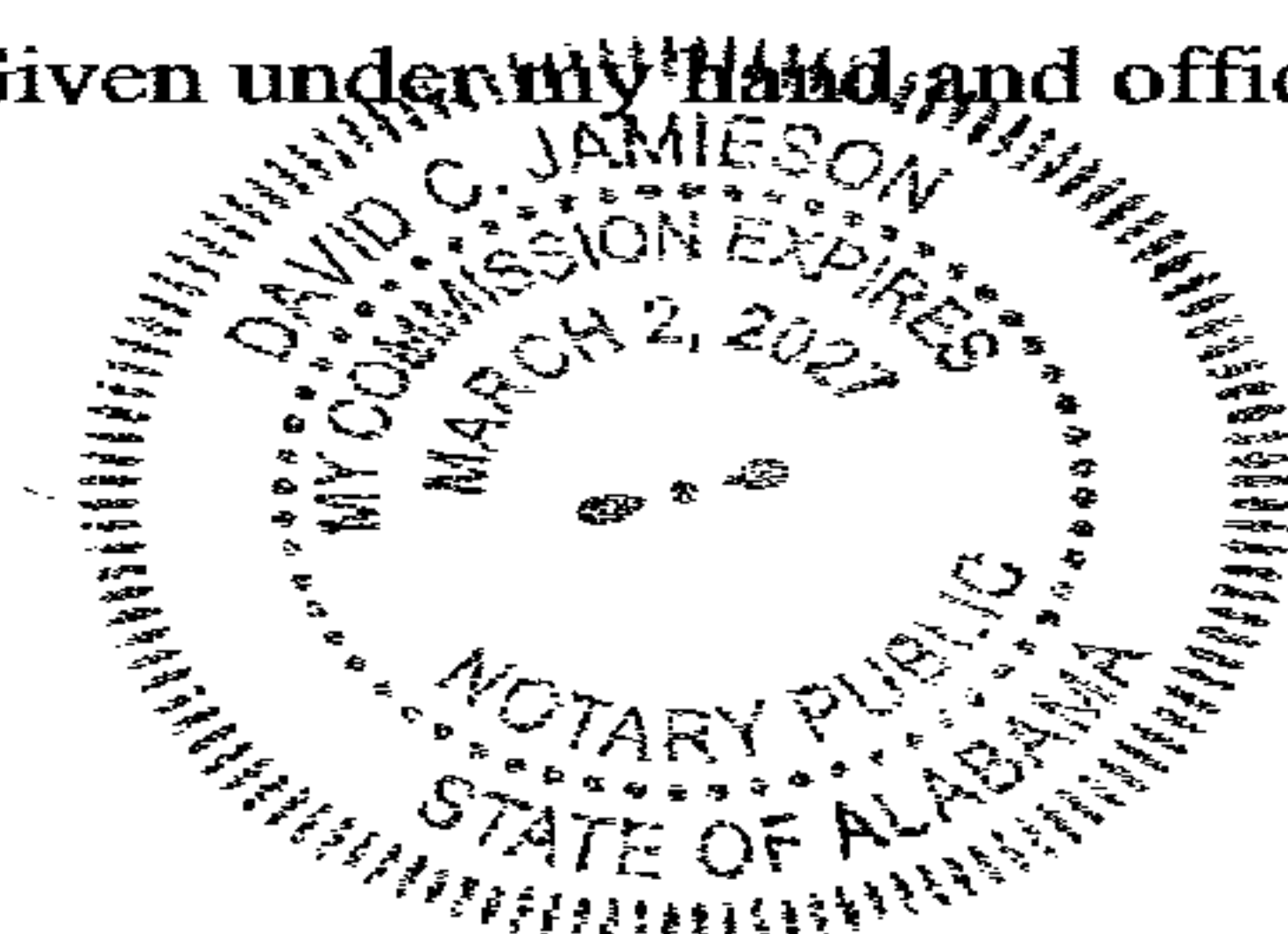

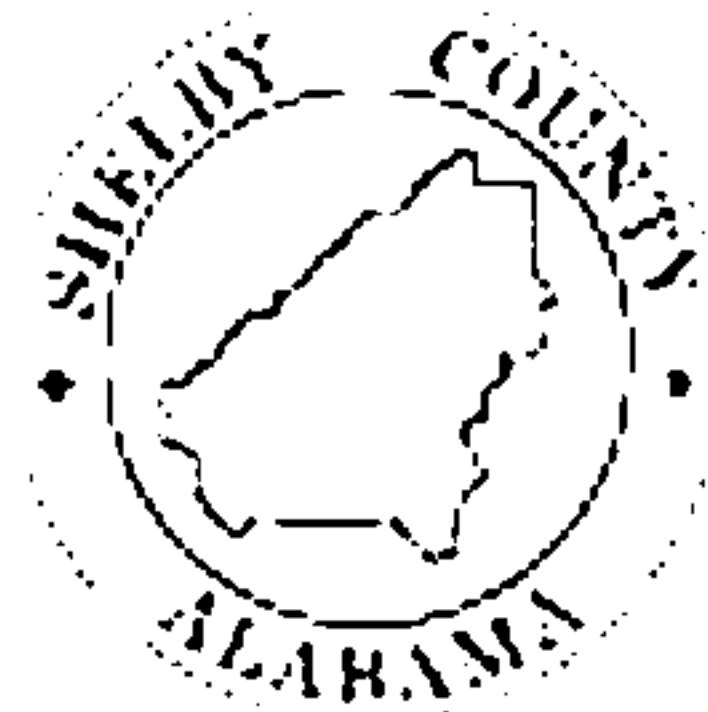
