4. To the best of my knowledge the following list represents the only children and/or descendants of Betty Joyce Hargrove:



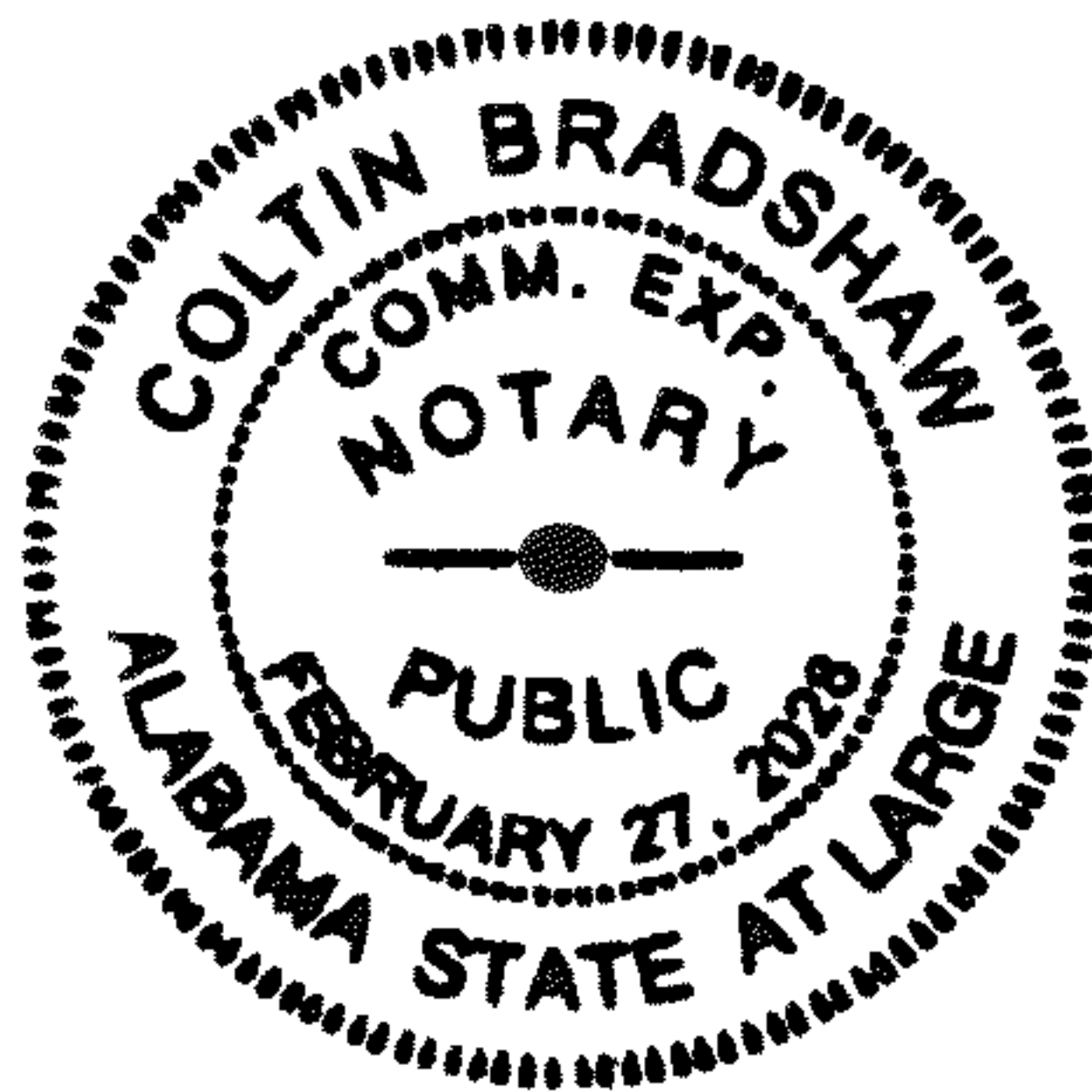
