Alexander** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Sean A. 

Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

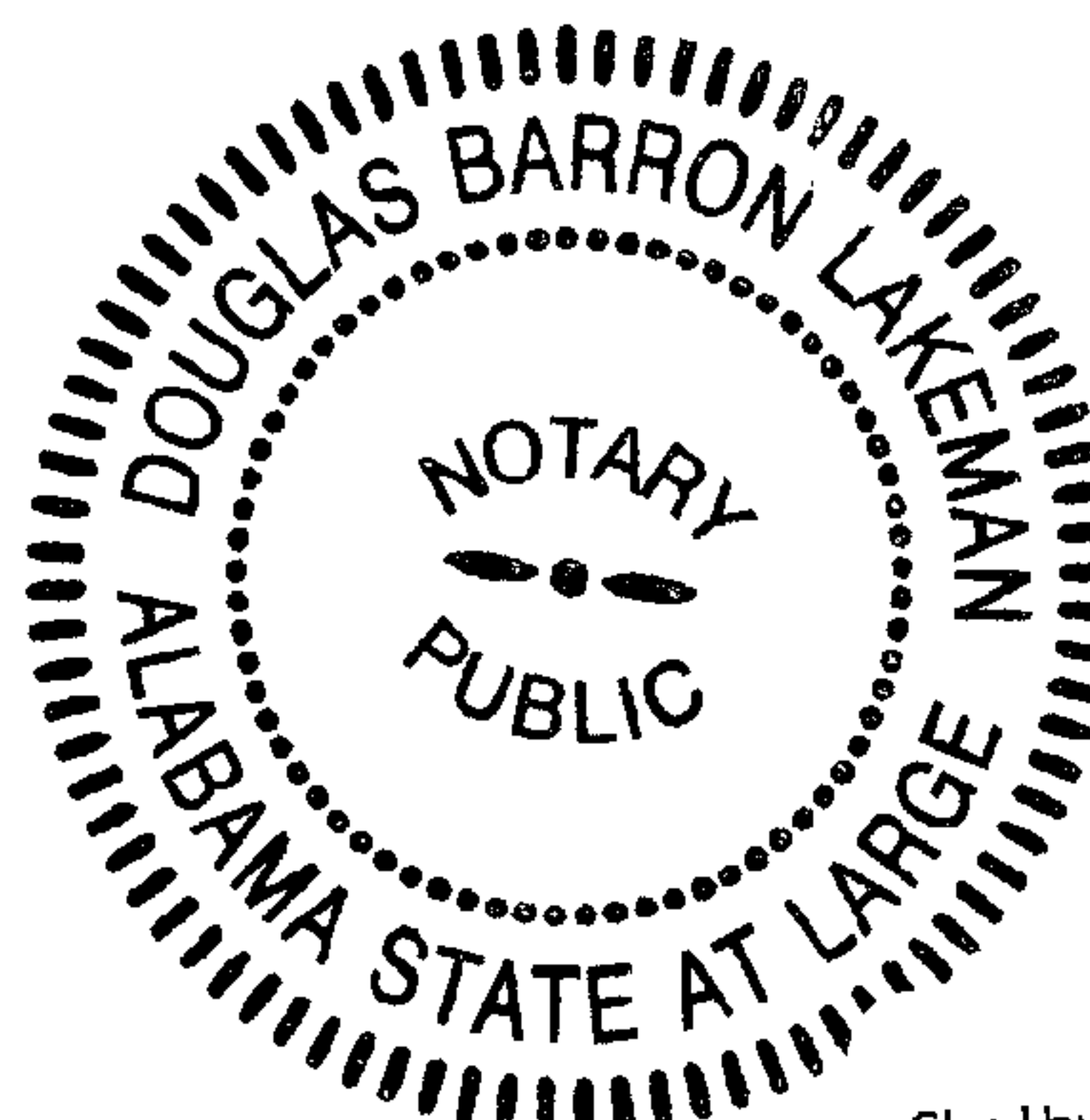
