KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Three Hundred Fifteen Thousand And No/100 Dollars (\$315,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Johnny Sullivan and Dancy Sullivan, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto James W. Clark and Crystal D. Clark (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

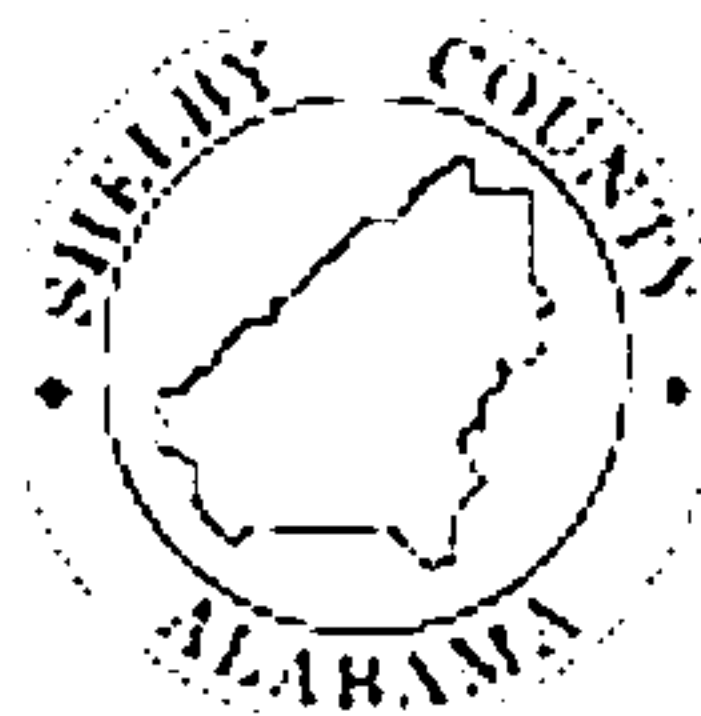
