Commence at the Southwest corner of the Southwest ¼ of the Southwest ¼ of Section 3, Township 19 South, Range 2 West, and run easterly along the south line of said quarter-quarter Section for a distance of 1004.07 feet; thence turn left an angle of 126 deg. 36 min. 00 sec. and run northwesterly for a distance of 194.56 feet to the point of beginning of a curve to the right having a central angle of 44 deg. 37 min. 01.11 sec. and a radius of 1900 feet; thence run northwesterly then northeasterly along the arc of said curve for a distance of 1479.55 feet to the end of said curve; thence run northeasterly along the extended tangent of said curve for a distance of 1543.67 feet, being Point "A" for future reference, said point also being the Point of Beginning of a variable width Right-of-Way being bound on the northwesterly side by the currently existing Right-of-Way of Caldwell Mill Road and being bound on the southeasterly side by a line lying 60 feet southeasterly of and parallel to, the following described line; thence continue northeasterly along the last described course for a distance of 102.62 feet, more or less, to the Grantor's northeasterly property line and the end of said Right-of-Way.
