2. Jeremy M. Dipiazza is the Grantor of the trust.
3. Steven J. McCord is the Trustee of the Trust. The address of the Trustee is 119 Langston Place, Birmingham, AL 35242.
4. Steven J. McCord is living and during his lifetime has contributed money funds, real property, and/or personal property to the trust.
5. The Successor Trustees of the Trust are Sandra Seagers McCord; Megan Ashley McCord and Christian Joseph McCord, or the other or survivor of them; and Jeremy M. Dipiazza.
6. The Trust is irrevocable.
7. The tax identification number of the trust is intentionally omitted for privacy reasons.
8. The Trust has not been revoked, modified or amended in any manner that would cause the representations and statements herein to be false or incorrect.
9. The Trust is valid. The same person is not the sole Trustee and the sole beneficiary, and the Trust has a definite beneficiary.
10. The Trustee under the Trust is authorized to acquire, sell, convey, encumber, lease, borrow, manage and otherwise deal with interests in real and personal property in the Trust name.
11. Third parties are entitled to rely on the authority of the successor Trustee without proof of his or her succession.

12. Title to assets in the Trust shall be taken as follows:

Steven J. McCord, Trustee of the Steven J. McCord 2011 Irrevocable Trust dated January 1, 2011, and any amendments thereto.

In addition, for titling purposes, any description referring to the Trust shall be effective if it includes the name of the Trust, the name of at least one Trustee or successor Trustee and any reference indicating that property is being held by the Trustee in a fiduciary capacity.

13. No person or entity paying money to or delivering property to the Trustee shall be required to see its application. All persons relying on this document regarding the Trustee and his powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A Copy of this Certificate of Trust shall be just as valid as the original.

14. This instrument is being executed by the Affiant, solely in his fiduciary capacity as named herein, and neither this instrument nor anything herein contained shall be construed as creating any indebtedness or obligation on the part of the undersigned in his individual capacity.
