MEMORANDUM OF LEASE

- 1. <u>Demised Premises</u>. The demised premises leased by Lessor to Lessee is the real property located at 2014 Fulton Springs Road, Alabaster, Alabama 35007, Shelby County, as more particularly described in <u>Exhibit A</u> attached hereto and incorporated herein by this reference, together with all rights, privileges and appurtenances associated therewith, and all buildings, fixtures and other improvements now or hereafter located on such real property.
- 2. <u>Term.</u> Subject to the terms and conditions of the Lease, the term of the Lease shall commence on December 21, 2023 and shall terminate on December 31, 2027, unless otherwise extended by Lessee.
- 3. Extension Options. Lessee may extend the initial term of the Lease for one (1) additional term of six (6) years, exercisable by Lessee in accordance with the terms of the Lease.
- 4. Right of First Refusal. During the term of the Lease, Lessee has a right of first refusal to purchase the fee interest in the Demised Premises, subject to and in accordance with the terms of the Lease.
- 5. <u>Incorporation</u>. The terms and provisions set forth in the Lease are hereby incorporated into this Memorandum by this reference, all of which such terms and provisions are made a part of this Memorandum as though fully set forth herein. In the event of any conflict between the terms and provisions set forth in this Memorandum and the terms and provisions set forth in the Lease, the terms and provisions set forth in the Lease shall govern. Capitalized terms used herein but not otherwise defined shall have the meaning ascribed to such term in the Lease.

6. <u>Counterparts</u>. This Memorandum may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which when so executed and delivered shall be an original but such counterparts together shall constitute one and the same instrument.
