WARRANTY DEED
JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

} Know All Men by These Presents:

County of Shelby

That in consideration of the sum of **Seven Hundred Thousand Dollars and No Cents (\$700,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Charlie Stephenson and Donna Stephenson**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Eric Anderson and Shelley Anderson**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit:

Lot 1A, according to a resurvey of Lots 1,2,3,4 and 5 of Bucklew Family Subdivision, as recorded in Map Book 53, Page 89A, in the Probate Office of Shelby County, Alabama.

Property may be subject to taxes for 2024 and subsequent years, all covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded.

\$560,000.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

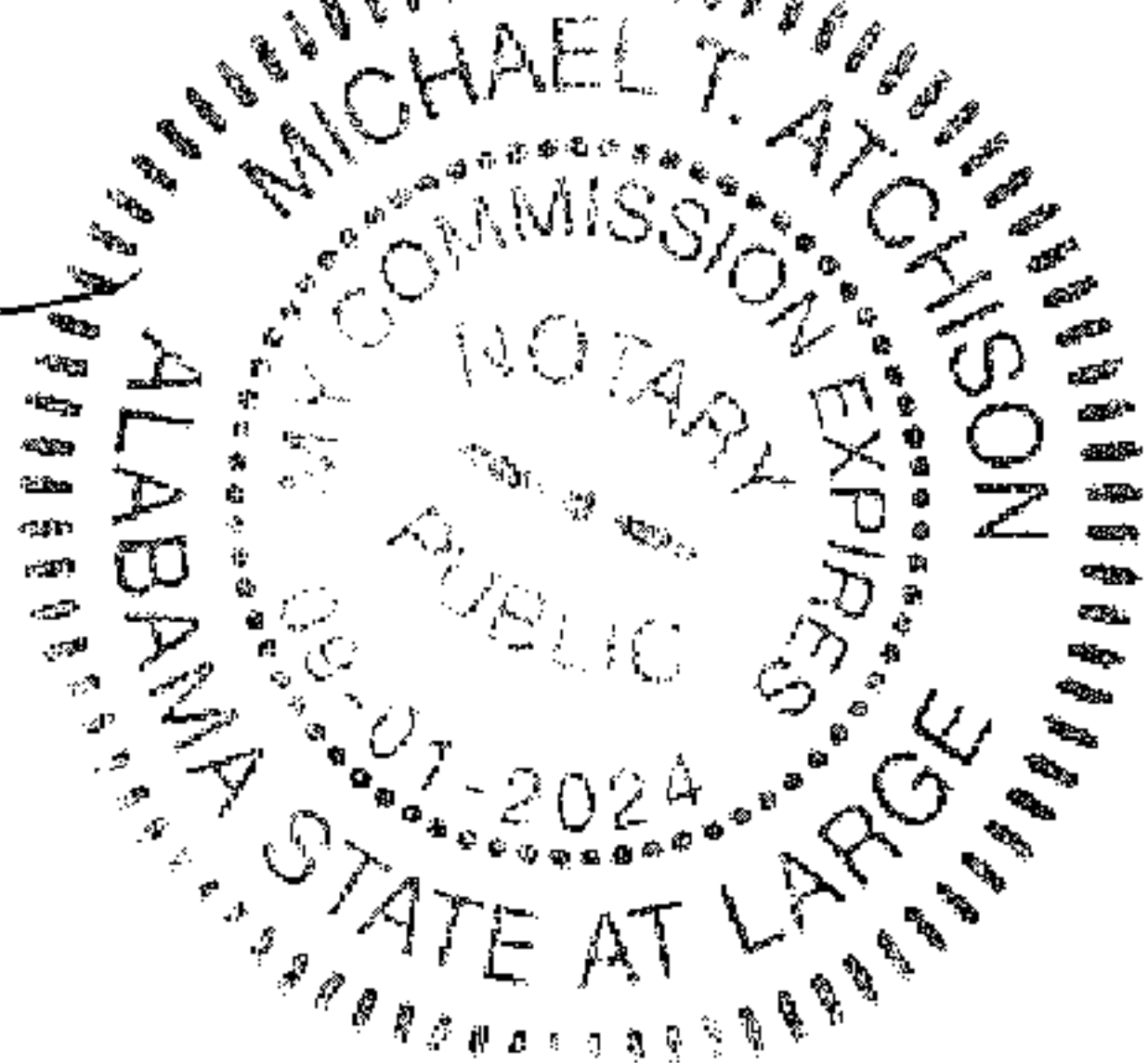

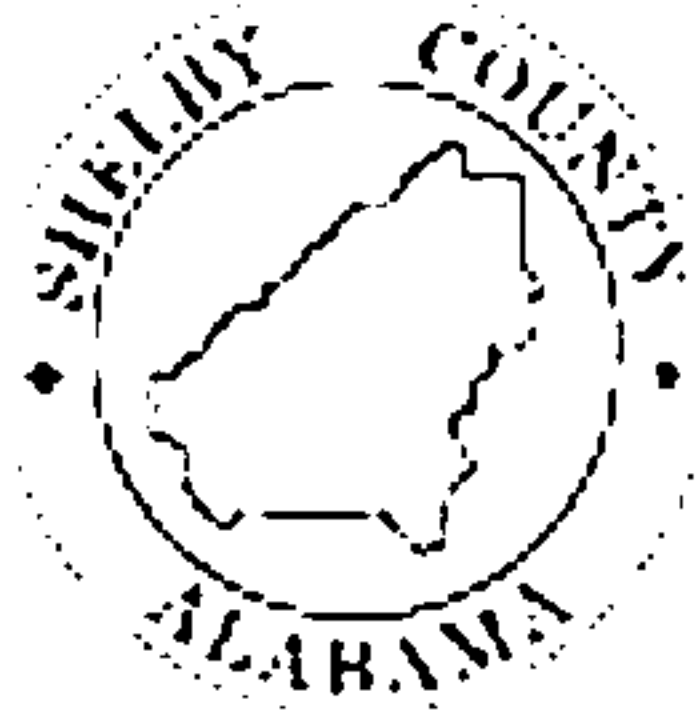
