Article I. Assignment of Authority

KD - **Sale of Real Estate:** My agent is authorized to act in my behalf for the purpose of selling the lands and premises located anywhere within the state of Alabama. My agent is authorized to perform any and all acts related to such sale, including, but not limited to, executing, modifying and delivering any and all documents necessary to complete the transaction as well as accepting the closing proceeds on my behalf.

KD - **Management of Real Estate:** My agent is authorized to act on my behalf for the purpose of managing the premises located anywhere within the state of Alabama. My agent is authorized to perform all acts related to maintaining the property such as but not limited to: making repairs (with reimbursement), approving sub-contractors for work, negotiating rents, signing lease/sublease agreements, evicting tenants and any other representation as needed for day-to-day management.

KD - **Purchase & Management of Liens:** My agent is authorized to act in my behalf for the purpose of purchasing, assigning, selling, placing, or enforcing a lien on lands and premises located anywhere within the state of Alabama. 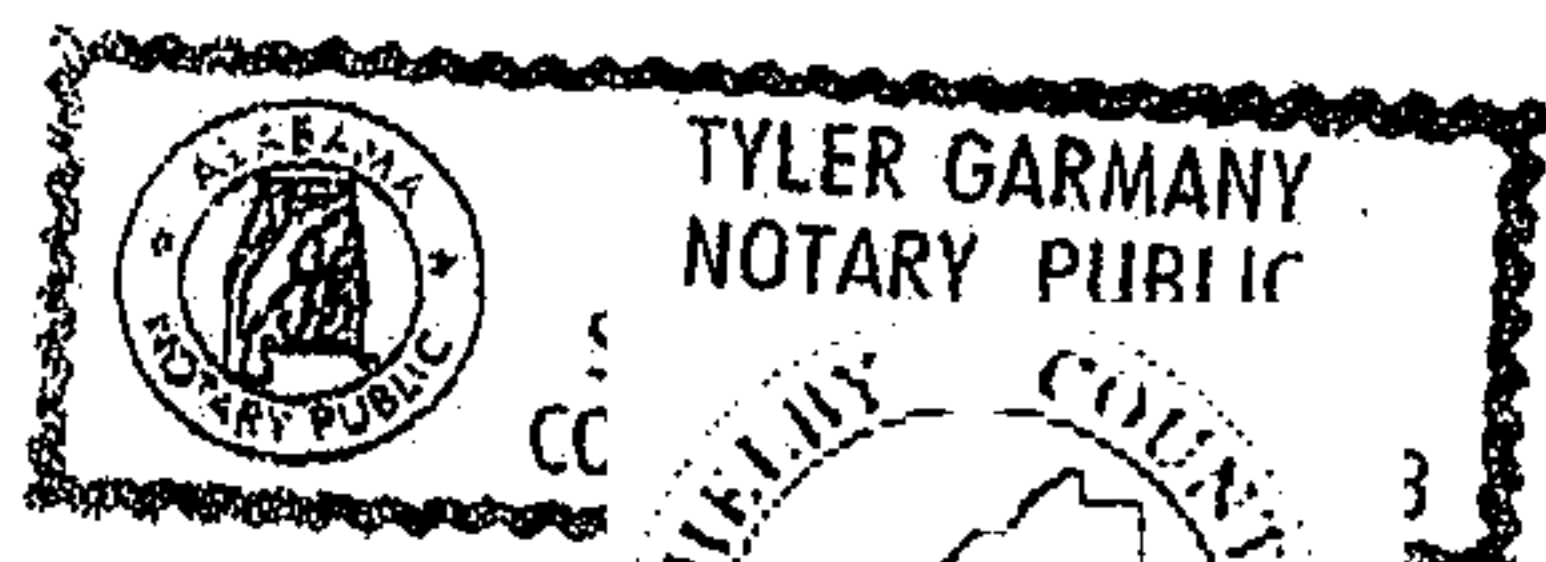
