THIS MODIFICATION OF MORTGAGE dated August 12, 2024, is made and executed between Hugh A Johnson, a married man, whose address is 2313 Maury Place, Birmingham, AL 35242 and Shari C Johnson, a married women, whose address is 2313 Maury Place, Birmingham, AL 35242 (referred to below as "Grantor") and Renasant Bank, whose address is 119 6th Avenue NE, Decatur, AL 35601 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated August 27, 2020 (the "Mortgage") which has been recorded in Shelby County, State of Alabama, as follows:

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

Increase Maximum Principal Indebtedness from \$200,000.00 to \$400,000.00

The Maturity date of the Note has been extended to 8/25/2034.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

This Modification is intended to be a modification only and not a discharge or novation of the Mortgage or the Note secured thereby, and is not intended to, and shall not in any manner, impair the lien or affect the validity or priority of the Mortgage as security for the Note or any and all other indebtedness secured thereby whether incurred, advanced or otherwise arising before or after the date of this Modification. The Mortgage is extended to and shall continue to secure the Note as previously, contemporaneously or hereafter renewed, extended, refinanced and/or modified, regardless of whether such renewal, extension, refinancing or modification is evidenced by a further modification or amendment of the Mortgage.
