WHEREAS that certain Declaration of Covenants, Conditions and Restrictions for Belvedere Cove Homeowners' Association, Inc. 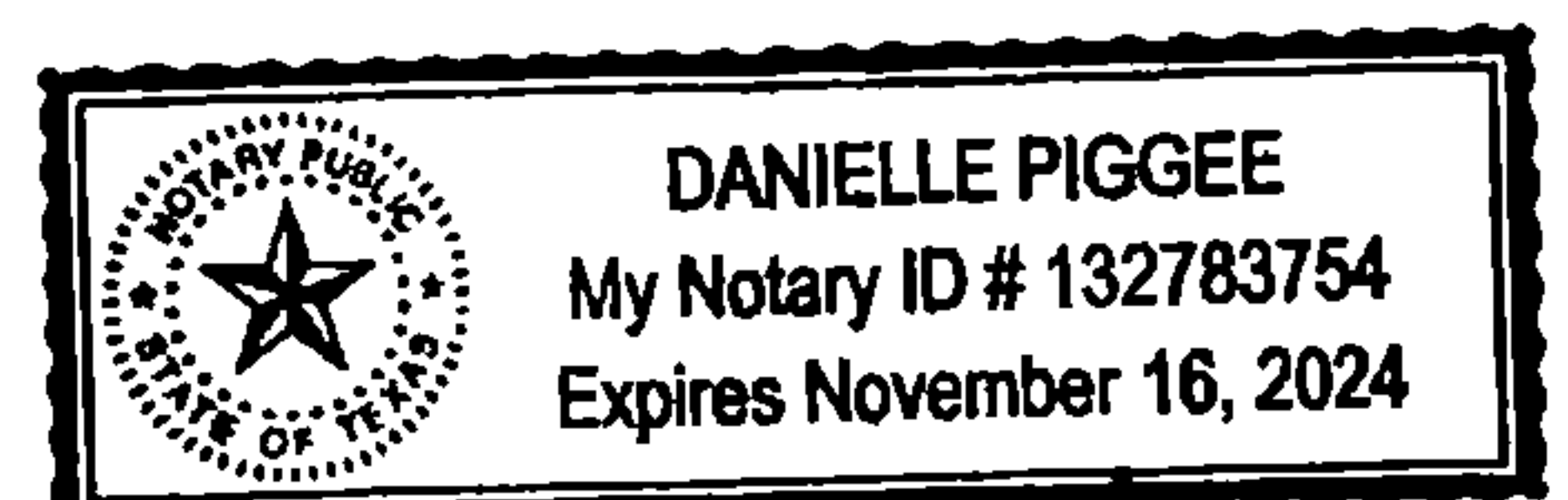
