That in consideration of **Three Hundred Fifty Thousand 00/100s Dollars (\$350,000.00)**, between the parties hereto, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged. I or we, **Mary B. Arledge and Joseph S. Arledge, a married couple** (herein referred to as grantor, whether one or more) whose mailing address is 7611 Hwy 22, Montevallo, Al 35115 grant, bargain, sell and convey unto, **James M. Barnett and Sharee Barnett** herein referred to as grantees) whose mailing address is 7706 Hwy 22, Montevallo, Al 35115 for and during their joint lives as joint tenants and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in **Shelby County, Alabama**, having an address: **7706 Hwy 22, Montevallo, AL 35115** to wit:

Lot 1, according to the Map and Survey of Arledge Subdivision, as recorded in Map Book 60, Page 40, in the Probate Office of Shelby County, Alabama.

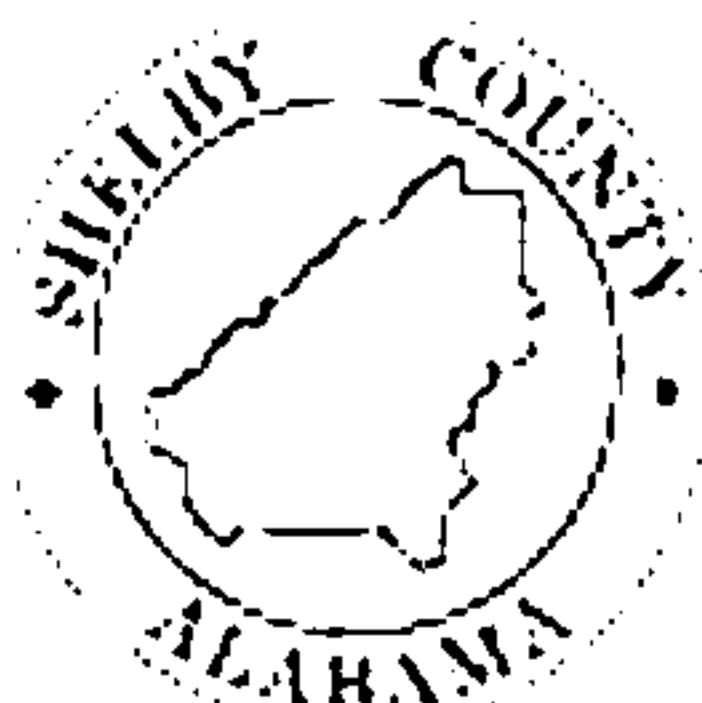

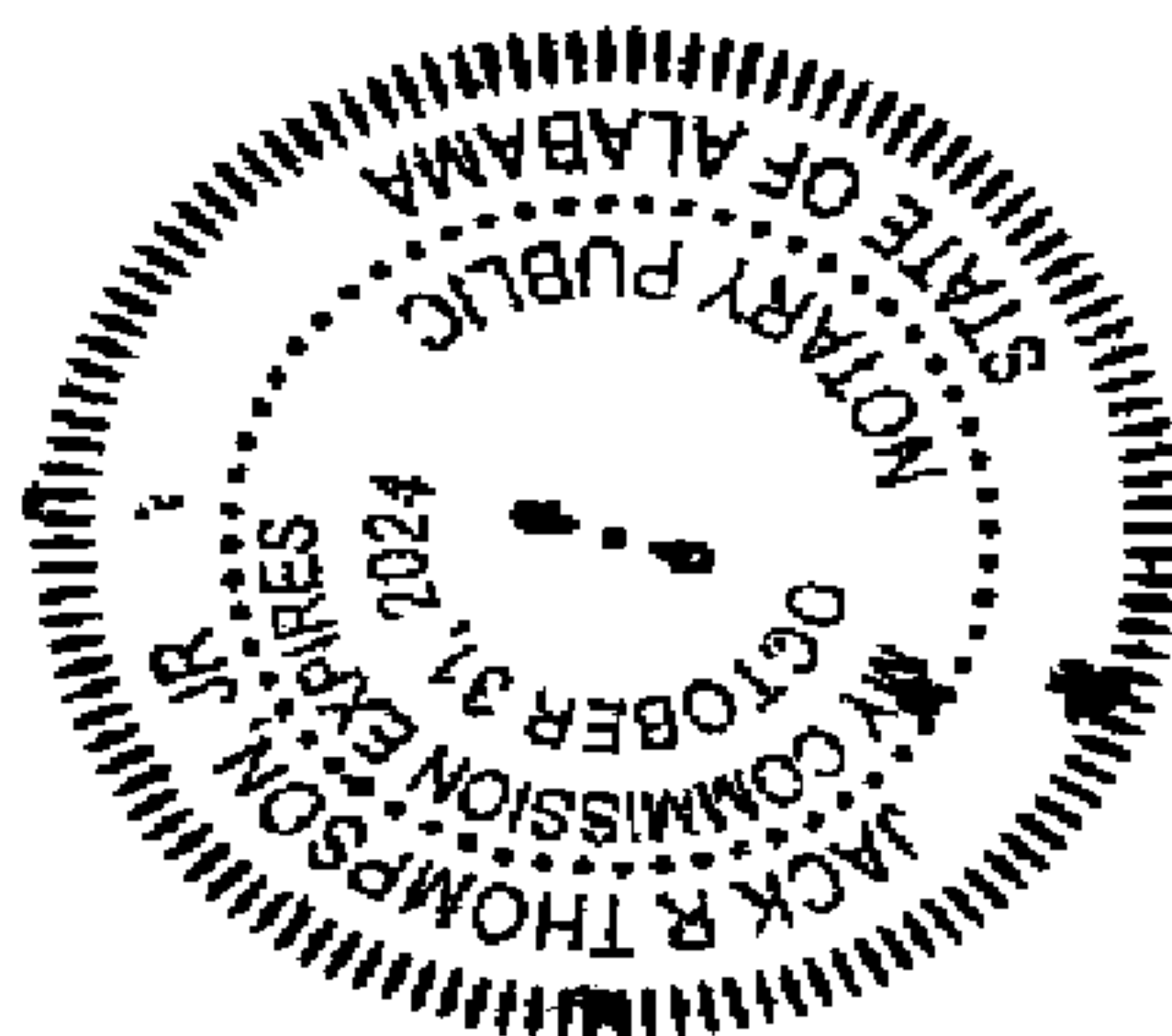
