WARRANTY DEED

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

On this August 23, 2024, That for and in consideration of **ONE HUNDRED NINETY FIVE THOUSAND AND NO/100 (\$195,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **MICHAEL RAY HALBERT, an unmarried person**, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **ASHLEY COX HONNOLL**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Unit A, Building 3, Lot 3 of Chandalar South Townhouses, as recorded in Map Book 6, Page 6, and revised and recorded in Map Book 7, Page 166, in the Probate Office of Shelby County, Alabama, more particularly described as follows: Commence at the most westerly corner of Lot 3; thence in a southeasterly direction along the southwest line of Lot 3 a distance of 40.97 feet; thence 90 degrees left in a northeasterly direction a distance of 20 feet to the Point of Beginning; said point being further identified as being the point of intersection of the centerline of the wood fence enclosing the fronts of Units "A", "B", "C" and "D" and the center line of the wood fence common to Units "A" and "B", thence continue in a northeasterly direction along the center line of said fence, party wall and fence a distance of 68.00 feet to intersection of the centerline of a fence enclosing the backs of Units "A", "B", "C" and "D"; thence right in a southeasterly direction along center line of last described fence a distance of 24.13 feet to intersection of the center line of the wood fence common to Units "B" and "C"; thence right in a southwesterly direction along the center line of said fence, wall and fence being the southeast side of Unit "D" a distance of 68 feet to the intersection of the center line of the fence enclosing the fronts of Units "A", "B", "C" and "D"; thence right in a northwesterly direction along the center line of last described fence a distance of 24.08 feet to a point of beginning.

Subject to:

1. General and special taxes or assessments for the year 2024 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.

- 6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 7, Page 166.

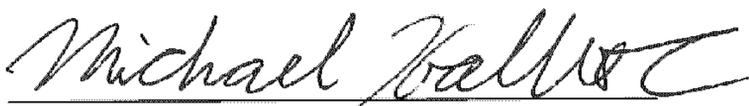
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.
