MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, September 9, 2021, **Hamilton C Arnall, III, An Unmarried Man, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc., as mortgagee, as nominee for Fairway Independent Mortgage Corporation, its successors and assigns**, which said mortgage is recorded in Instrument No. 20210930000477200 as modified by that certain Modification Agreement in Instrument No. 20230623000186730, in the Office of the Judge of Probate of Shelby County, Alabama.; and

WHEREAS, on August 22, 2024, the day on which the foreclosure sale was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted and Nationstar Mortgage LLC did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse; and



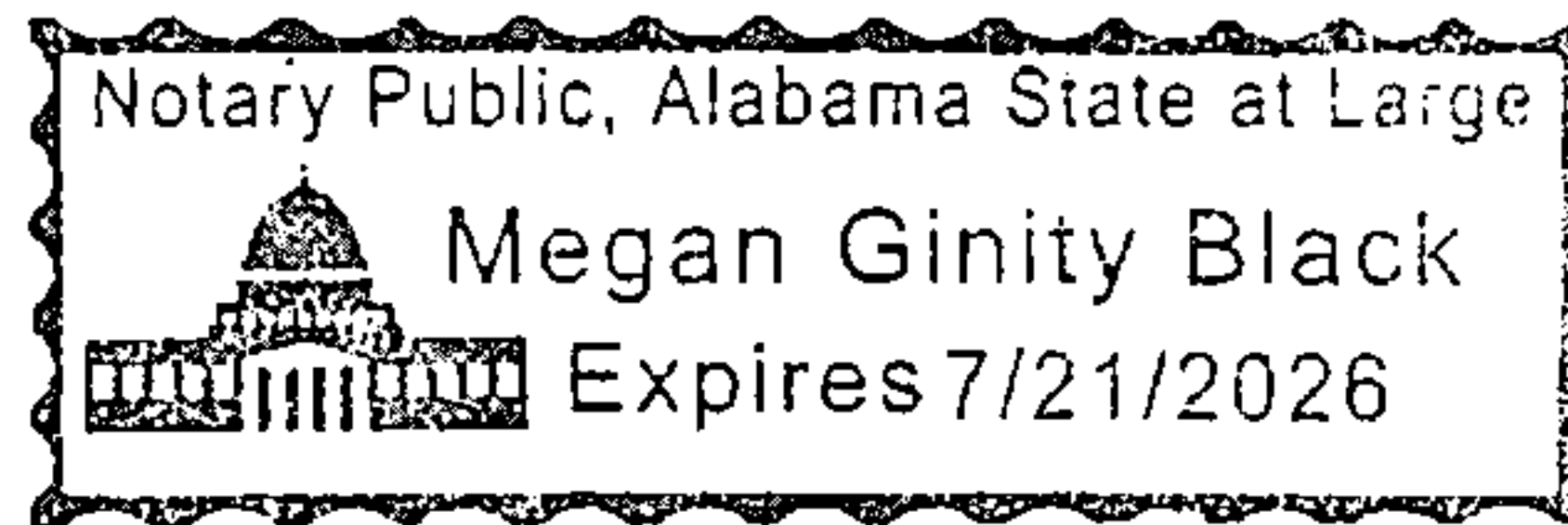

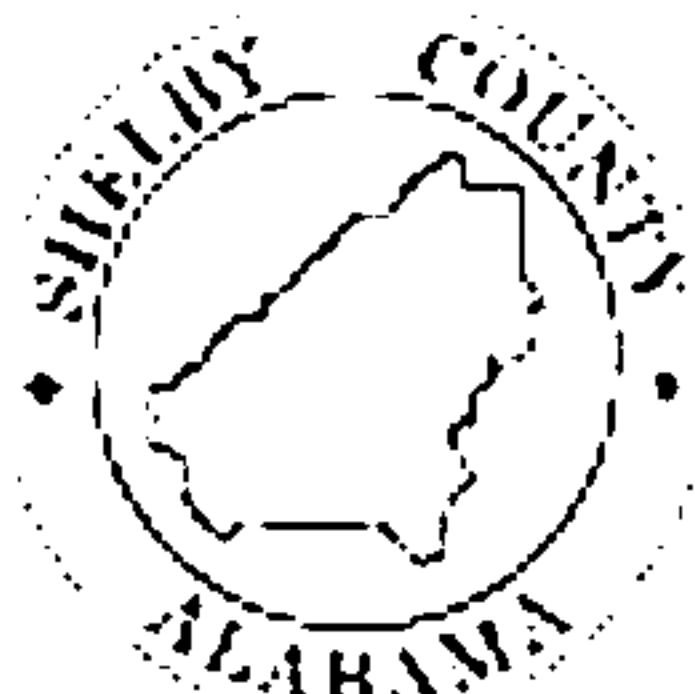
