JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

That in consideration of the sum of **Three Hundred Eighty Nine Thousand Dollars and No Cents (\$389,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Sharon Radigan, Trustee, or her successors in interest, of The Radigan Living Trust, dated October 18, 2023, and any amendments thereto**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Richard L. King Jr. and Rebecca L. King** as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

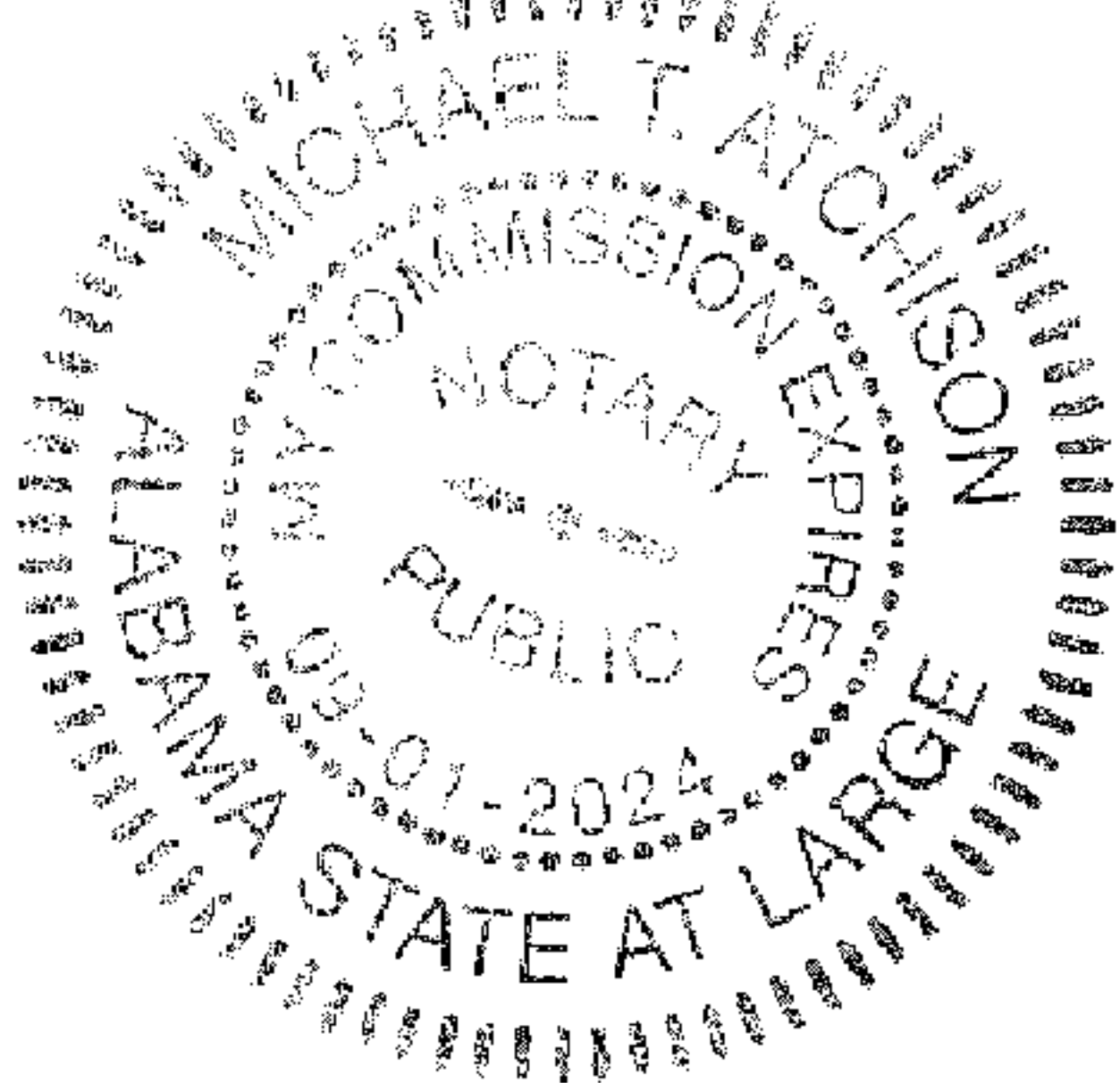
